APPLICATION FOR A TRANSFER OF INDIVIDUAL ELECTRONIC COMMUNICATIONS SERVICE LICENCE FROM FREE SPACE OPTICS INTERNATIONAL (PTY) LTD TO CONNECT VOICE CONNECT DATA (PTY) LTD

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received application from Free Space Optics International (Pty) Ltd for a transfer of its Individual Electronic Communications Service (I-ECS) licence. The application was lodged in terms of regulation 11 of the Processes and Procedures Regulations for Individual Licences and Special Temporary Authorisations of 2010 read with sections 13(1), (2) and (6) of the Electronic Communications Act, as amended.
2. The transfer application seek the approval from the Authority to transfer the I-ECS licence from Free Space Optics International (Pty) Ltd to Connect Voice Connect Data (Pty) Ltd.

Free Space Optics International (Pty) Ltd shall be entitled to respond in writing to written representations made by interested persons on the transfer application, and such written response must be lodged with the Authority within forty two (42) working days from the date of publication of this notice in the Government Gazette. Free Space Optics International (Pty) Ltd must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, OR has sent a copy of such response by registered mail OR by facsimile OR by e-mail to the relevant person having made such written representations.
