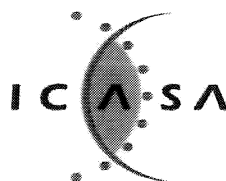

NOTICE OF PUBLIC HEARINGS: INQUIRY INTO THE STATE OF COMPETITION IN THE INFORMATION AND COMMUNICATIONS TECHNOLOGY SECTOR

The Independent Communications Authority of South Africa ("ICASA") hereby, in accordance with section 4 B and C of the Independent Communications Authority of South Africa Act ("ICASA Act") No.13 of 2000 as amended, gives notice to convene oral hearings on the public inquiry into the state of competition in the Information and Communications Technology Sector.

ICASA published the notice of public inquiry into the state of the competition in the Information and Communications Technology sector on 20 March 2014, General Notice 229, Government Gazette Number 37456. The Authority invited interested parties, stakeholders, and the public to respond to the issues raised in the inquiry. The closing date for the receipt of written representations was 23 June 2014. The Authority received fourteen submissions. Twelve of these have indicated their wish to make oral presentations.

Public hearings will be convened on the 01st to the 03rd of October 2014.


