### SIXTH AMENDMENT OF THE CIVIL AVIATION REGULATIONS, 2011

## Amendment of Part 187 of the Regulations

2. Part 187 of the Regulations is hereby amended by the substitution in Regulation 187.02.1 for sub-regulation (1) of the following sub-regulation:

"(1) A civil aviation authority passenger safety charge amounting to R16.39 shall be payable by aircraft passengers departing on an aircraft from an aerodrome within the Republic of South Africa on a scheduled public air transport flight or part of a flight to a destination within or outside the territory of the Republic of South Africa.".

### Short title and commencement

3. This Amendment is called the Sixth Amendment of the Civil Aviation Regulations and shall come into operation on 1 November 2014.
