### HEALTH PROFESSIONS ACT, 1974 (ACT NO. 56 OF 1974)

#### REGULATIONS RELATING TO THE REGISTRATION BY ENVIRONMENTAL HEALTH PRACTITIONERS OF ADDITIONAL QUALIFICATIONS: AMENDMENT

The Minister of Health has, under Section 35 (2) of the Health Professions Act, 1974 (Act No. 56 of 1974) and after consultation with the Health Professions Council of South Africa, made the Regulations in the Schedule.

#### SCHEDULE

##### Definitions

1. In these Regulations "**the Regulations**" means Regulations relating to the registration by Environmental Health Practitioners of additional qualifications published under Government Notice No. R. 2309 of 3 December 1976, as amended by *Government Notices Nos. R. 1037 of 26 May 1978, R. 2462 of 30 October 1987, R. 144 of 05 February 1988, R. 2441 of 02 December 1988, R. 473 of 17 March 1989, R. 953 of 03 April 1992, R. 2338 of 21 August 1992, and R. 897 of 13 May 1994.*

##### Amendment of the Regulations.

2. The Regulations are hereby amended by:-
  - (a) the substitution, for the examining authority "Medical University of South Africa", of the examining authority "University of Limpopo"; and

(b) the addition of the following qualifications:-
