

#### ELECTRONIC COMMUNICATIONS ACT, 2005 (ACT NO. 36 OF 2005)

#### APPLICATIONS FOR A TRANSFER OF INDIVIDUAL ELECTRONIC COMMUNICATIONS SERVICE AND INDIVIDUAL ELECTRONIC COMMUNICATIONS NETWORK SERVICE LICENCES FROM LITMUS COMPUTER SOLUTIONS CC T/A NETPOINT TO TWK COMMUNICATIONS CC

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received applications from Litmus Computer Solutions cc for a transfer of its Individual Electronic Communications Service (I-ECS) and Individual Electronic Communications Network Service (I-ECNS) licences. The applications were lodged in terms of regulation 11 of the Processes and Procedures Regulations for Individual Licences and Special Temporary Authorisations of 2010 read with sections 13(1), (2) and (6) of the Electronic Communications Act, as amended.
2. The transfer applications seek the approval from the Authority to transfer the I-ECS and I-ECNS licences from Litmus Computer Solutions cc to TWK Communications cc.
3. The applications, relevant schedule and any representations received pursuant thereto would be made available and open for inspection by interested parties in the Authority's library during the Authority's normal office hours.
4. Interested parties are invited to lodge written representations in relation to the applications within twenty one (21) working days from the date of publication of this notice in the Government Gazette.

5. Persons who make such representations must indicate in their written representations whether they require an opportunity to make oral representations in the event the Authority decides to hold public hearings.
6. Litmus Computer Solutions cc shall be entitled to respond in writing to written representations made by interested persons on the transfer applications, and such written response must be lodged with the Authority within forty-two (42) working days from the date of publication of this notice in the Government Gazette. Litmus Computer Solutions cc must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, **OR** has sent a copy of such response by registered mail **OR** by facsimile **OR** by e-mail to the relevant person having made such written representations.
