


**PROCLAMATION***by the**President of the Republic of South Africa***No. 73, 2014****AMENDMENT TO THE TERMS OF REFERENCE OF THE COMMISSION OF INQUIRY INTO ALLEGATIONS OF FRAUD, CORRUPTION, IMPROPRIETY OR IRREGULARITY IN THE STRATEGIC DEFENCE PROCUREMENT PACKAGE**

Under the powers vested in me by section 1 of the Commissions Act, 1947 (Act No. 8 of 1947), read in conjunction with paragraph 2 of the Terms of Reference, I hereby, with effect from 30 November 2014, amend the Terms of Reference of the Commission of Inquiry into allegations of fraud, corruption, impropriety or irregularity in the Strategic Defence Procurement Package, as published under Government Notice No. R. 926 in *Government Gazette* No. 34731 of 04 November 2011, as indicated in the Schedule hereto.

## Definition

1.     In this Proclamation "Terms of Reference" means the terms of reference published under Government Notice No. R. 926 of 4 November 2011.

## Amendment of the Terms of Reference

2.     The Terms of Reference is hereby amended by the substitution for paragraph 4 of the following paragraph:

"4.     The Commission shall submit interim reports and recommendations to the President from time to time and at least every six months prior to the finalisation of its report for presentation to the President. The Commission shall complete its work **[by no later than 30 November 2014]** by no later than 30 April 2015 and shall submit its final report to the President within a period of six months after the date on which the Commission completes its work."

## Commencement

3.     The amendment to the Terms of Reference published under this Proclamation shall come into operation on 30 November 2014.
