MAGISTRATES' COURTS ACT, 1944 (ACT NO. 32 OF 1944): VARIATION OF GOVERNMENT NOTICE NO. 670 OF 2010


I, Tshililo Michael Masutha, Minister of Justice and Correctional Services, acting under section 2(1)(iA) and (j) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944), with effect from 1 December 2014, vary Schedule 1 to Notice No. 670 of 29 July 2010 in respect of the Gauteng and North West Regional Divisions by—

- (a) deleting Heidelberg in Column "D" as a local limit of the area of jurisdiction of the court sitting at Springs;
- (b) appointing Heidelberg as a place for the holding of a court for the adjudication of civil disputes;
- (c) prescribing Lesedi Magisterial District in Column "D" within which the court sitting at Heidelberg shall have jurisdiction;
- (d) deleting Benoni in Column "D" as a local limit of the area of jurisdiction of the court sitting at Kempton Park ;
- (e) appointing Benoni as a place for the holding of a court for the adjudication of civil disputes;
- (f) prescribing Ekurhuleni South East in Column "D" as a local limit within which the court sitting at Benoni shall have jurisdiction;
- (g) appointing Sebokeng sub-district as a place for the holding of a court for the adjudication of civil disputes;
- (h) prescribing Sebokeng sub-district as a local limit within which the court sitting at Sebokeng shall have jurisdiction;
- (i) deleting Pretoria North in Column "D" as a local limit of the area of jurisdiction of the court sitting at Pretoria;

- (j) appointing Pretoria North as a place for the holding of a court for the adjudication of civil disputes;
- (k) prescribing Tshwane North Magisterial District as a local limit within which the court sitting at Pretoria North shall have jurisdiction;
- (l) deleting areas in Column "D" as a local limit of the area of jurisdiction of the court sitting at Kliptown;
- (m) prescribing Soweto sub-district in Column "D" as a local limit within which the court sitting at Kliptown shall have jurisdiction;
- (n) deleting Krugersdorp in Column "D" as a local limit of the area of jurisdiction of the court sitting at Roodepoort;
- (o) appointing Kagiso as a place for the holding of a court for the adjudication of civil disputes;
- (p) prescribing Mogale City Magisterial District as a local limit within which the court sitting at Kagiso shall have jurisdiction;
- (q) deleting Lichtenburg and Ditsobotla (Itsoseng) in Column "D" as a local limit of the area of jurisdiction of the court sitting at Mmabatho;
- (r) deleting Coligny in Column "D", as a local limit of the area of jurisdiction of the court sitting at Potchefstroom;
- (s) describe Ditsobotla Magisterial District as a local limit within which the court sitting at Lichtenburg shall have jurisdiction;
- (t) deleting Taung in Column "D", as a local limit of the area of jurisdiction of the court sitting at Vryburg;
- (u) appointing Taung as a place for the holding of a court for the adjudication of civil disputes;
- (v) prescribing Greater Taung Magisterial District as a local limit within which the court sitting at Taung shall have jurisdiction;
- (w) deleting Mankwe and Madikwe in Column "D" as a local limit of the area of jurisdiction of the court sitting at Rustenburg;
- (x) appointing Mankwe (Mogwase) as a place for the holding of a court for the adjudication of civil disputes;
- (y) prescribing Moses Kotane Magisterial District as a local limit within which the court sitting at Mankwe shall have jurisdiction;
- (z) deleting Christiana and Bloemhof in Column "D" as a local limit of the area of jurisdiction of the court sitting at Klerksdorp;

- (aa) appointing Bloemhof as a place for the holding of a court for the adjudication of civil disputes; and
- (bb) prescribing Lekwa-Teemane Magisterial District as a local limit within which the court sitting at Bloemhof shall have jurisdiction.
