Given under my hand at Cape Town on this the 29 day of October Two Thousand and Fourteen.

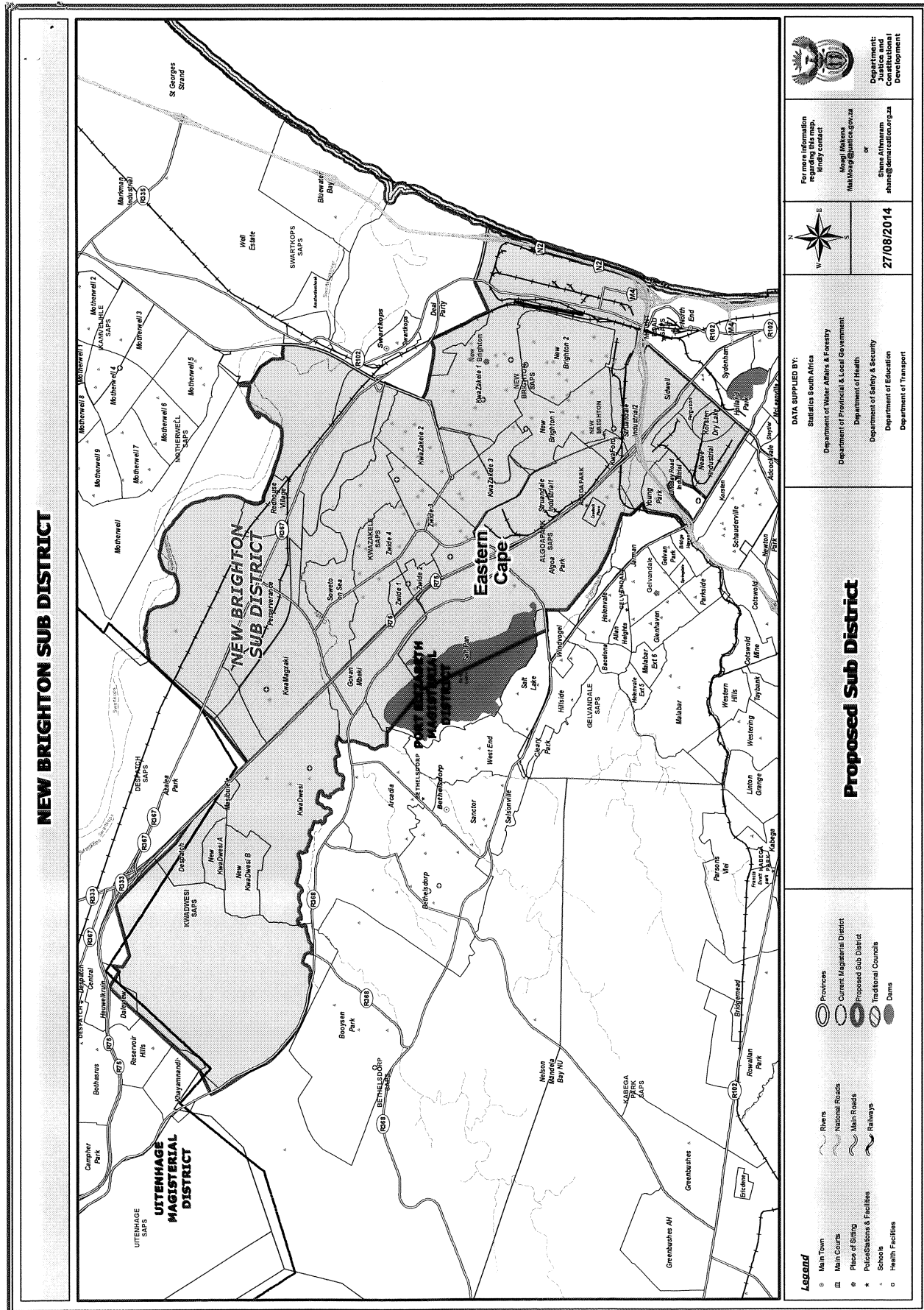

## POINT-TO-POINT DESCRIPTION

BRANCH COURT	DESCRIPTION	MAIN SEAT
New Brighton	Starting from the intersection of Swartkops river and the Uitenhage Magisterial District boundary. Proceed East along the Swartkops river to intersect R102, proceed South and then East along the Motherwell sub-district boundary to intersect the magisterial boundary on the East Coast. Proceed along the magisterial district boundary on the East Coast in a Southerly direction along the N2. Then proceed along the N2 in a Westerly direction to intersect with the Southern boundary between Gelvandale SAPS boundary. Proceed West along the Southern boundary of the Gelvandale SAPS boundary and then North along the boundary between Gelvandale SAPS and Kabega SAPS boundary. Proceed along the Northern boundary of Kabega Park SAPS and then along its Eastern boundary and then North along the boundaries of the farms Klaas Niemand, Rivier 403 and Kakkerlaks Vley 400 to intersect the Southern boundary of the KwaNobuhle SAPS and Uitenhage SAPS to intersect with the R368. Then proceed South and North West along the Port Elizabeth Magisterial District boundary to eventually intersects with the river alongside the R368 to the starting point of the description.
