MAGISTRATES' COURTS ACT, 1944 (ACT NO. 32 OF 1944): APPOINTMENT OF PLACES OF SITTING AND PERIODICAL COURTS FOR GAUTENG AND NORTH WEST PROVINCES

I, Tshililo Michael Masutha, Minister of Justice and Correctional Service, acting under section 2(1)(h) and (j) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944) read with Item 16(6) of Schedule 6 to the Constitution of the Republic of South Africa, 1996, in respect courts created in terms of notice No. 43 of 24 January 2014 and sub-districts created in terms of notice No. 860 of 31 October 2014, hereby, with effect from 1 December 2014, appoint places for holding of a court and periodical courts for the Gauteng and North West Provinces as indicated under Schedule 1 and 2, respectively.

Despite the establishment of the places for the holding of a court and periodical courts, criminal proceedings which have already been placed on the court roll for trial in the places of sitting or periodical courts, but have not started or have not yet been concluded, shall be proceeded with until the criminal proceedings have been concluded as if this notice never took effect.
