#### **MAGISTRATES' COURTS ACT, 1944 (ACT NO. 32 OF 1944): WITHDRAWAL OF NOTICES CREATING PLACES OF SITTING, AND PERIODICAL COURTS**

I, Tshililo Michael Masutha, Minister of Justice and Correctional Services, acting under section 2(1) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944) read with Item 16(6) of Schedule 6 to the Constitution of the Republic of South Africa, 1996, hereby with effect from 1 December 2014, abolish all the existing places of sitting and periodical courts by withdrawing the government notices whereby those places of sitting and periodical courts were created in respect of the Gauteng and North West Provinces as indicated in Schedule 1 and 2, respectively.
