- 1) With effect from the date of the publication of this notice an employer shall pay a contract cleaning worker at least the minimum wage prescribed in the schedule.
- 2) Despite clause 3(1), an employee who works for less than six (6) hours on any day must be paid for at least six (6) hours on that day.
