ESTABLISHMENT OF SMALL CLAIMS COURTS FOR THE AREAS OF EMPANGENI AND MTUNZINI AND WITHDRAWAL OF GOVERNMENT NOTICE NO. 2851 OF 31 DECEMBER 1987

I, John Harold Jeffery, Deputy Minister of Justice and Constitutional Development, acting under the power delegated to me by the Minister of Justice and Correctional Services, under section 2 of the Small Claims Courts Act, 1984 (Act No. 61 of 1984), hereby -

- (a) (i) establish a Small Claims Court for the adjudication of claims for the area of Empangeni, consisting of the district of Lower Umfolozi;
- (ii) determine Empangeni to be the seat of the said Court; and
- (iii) determine Empangeni and Richards Bay to be the places in that area for the holding of sessions of the said Court.
- (b) (i) establish a Small Claims Court for the adjudication of claims for the area of Mtunzini, consisting of the district of Mtunzini;
- (ii) determine Mtunzini to be the seat of the said Court; and
- (iii) determine Mtunzini to be the place in that area for the holding of sessions of the said Court.
- (c) withdraw Government Notice No. 2851 of 31 December 1987.

Despite the withdrawal of Government Notice No. 2851 of 31 December 1987, any claim emanating from the district of Mtunzini which has already been instituted in the Small Claims Court of Empangeni prior to the publication of this Government Notice, shall be continued and concluded in the Small Claims Court of Empangeni as if this Government Notice has not been published.
