PETROLEUM PRODUCTS ACT, 1977 (ACT No. 120 OF 1977)

REGULATIONS IN RESPECT OF THE SINGLE MAXIMUM NATIONAL RETAIL PRICE FOR ILLUMINATING PARAFFIN

- 1. I, Ms. Tina Joemat-Pettersson, Minister of Energy, under section 2(1)(c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), determine that a maximum retail price for Illuminating Paraffin (excluding the price of any form of packaging) will become effective on the first Wednesday of each month.
- 2. The maximum retail price for illuminating paraffin, excluding the price of any form of Packaging for the period 01 April 2015 to 05 May 2015 will be 957.0 c/l.

3. Commencement

These regulations shall come into operation at 00:01 on 01 April 2015
