PRIVATE SECURITY INDUSTRY REGULATION ACT, 2001 (ACT NO. 56 OF 2001): EXEMPTION IN TERMS OF SECTIONS 1(2) AND 20(5) OF THE ACT

By virtue of the power vested in the Minister of Police by sections 1(2) and 20(5) of the Private Security Industry Regulation Act, 2001 (Act No. 56 of 2001), I, Nkosinathi Phiwayinkosi Thamsanqa Nhleko, hereby determine that D Kambouris (I/D No. 400205 5046 082), D Sokhela (I/D No. 590930 0448 088), WD Winship (I/D No. 370409 5041 087), VC Biggs (I/D No. 350324 5016 084), DS Harrison (I/D No. 560312 0031 089), JA Voster (i/d No. 450712 5064 089), PD Dlamini (I/D No. 681001 0310 080), TF Davis (I/D No. 491018 5106 081) and ES Magwaza (I/D No. 650515 5980 081) are exempted from the provisions of sections 20(1) and 20(2) of the Private Security Industry Regulation Act, 2001 (Act No. 56 of 2001), for a period of five years from date hereof, on condition that -

- they may not directly or indirectly participate or influence the decisions relating to the day-to-day security services provided by City Msunduzi (Pty) Ltd;
- they may not function as security service providers ; and
- they remain in the employment of City Msunduzi (Pty) Ltd in the same position as indicated in their application.
