#### PETROLEUM PRODUCTS ACT, 1977 (ACT No. 120 OF 1977)

#### REGULATIONS IN RESPECT OF THE SINGLE MAXIMUM NATIONAL RETAIL PRICE FOR ILLUMINATING PARAFFIN

1. I, Ms. Tina Joemat-Pettersson, Minister of Energy, under section 2(1)(c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), determine that a maximum retail price for Illuminating Paraffin (excluding the price of any form of packaging) will become effective on the first Wednesday of each month.
2. The maximum retail price for illuminating paraffin, excluding the price of any form of Packaging for the period 01 July 2015 to 04 August 2015 will be 1014.0 c/l.
3. **Commencement**  
These regulations shall come into operation at **00:01 on 01 July 2015**
