

GPW Business Rules

1. No hand written notices will be accepted for processing, this includes Adobe forms which have been completed by hand.



- 3. Notices brought into GPW by "walk-in" customers on electronic media can only be submitted in Adobe electronic form format. This means that any notice submissions not on an Adobe electronic form that are submitted by the customer on electronic media will be <u>rejected</u>. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
- 4. All customers who walk in to GPW that wish to submit a notice that is not on an electronic Adobe form will be routed to the Contact Centre where the customer will be taken through the completion of the form by a GPW representative. Where a customer walks into GPW with a stack of hard copy notices delivered by a messenger on behalf of a newspaper the messenger must be referred back to the sender as the submission does not adhere to the submission rules.
- 5. All notice submissions that do not comply with point 2 will be charged full price for the notice submission.
- 6. The current cut-off of all Gazette's remains unchanged for all channels. (Refer to the GPW website for submission deadlines www.gpwonline.co.za)

BOARD NOTICE 143 OF 2015

CALL FOR NOMINATIONS OF CANDIDATES TO SERVE AS MEMBERS OF THE GAUTENG GROWTH AND DEVELOPMENT AGENCY BOARD

- I. The Member of the Executive Council (MEC) responsible for Economic Development in Gauteng Province hereby calls for nominations in terms of Section 8 of the Gauteng Growth and Development Agency (Proprietary) Limited Act, 2003 of candidates to serve on the Gauteng Growth and Development Agency Board.
- II. All interested persons are hereby invited to submit their written nominations for appointment as members of Gauteng Growth and Development Agency Board.
- III. The MEC must constitute and appoint a Board of not less than nine (9) and not more than twelve (12) members including:
 - a non-executive Chairperson;
 - a non-executive Deputy Chairperson;
 - the CEO who shall be an ex officio member of the Board of Directors;
 - one member who by virtue of his or her training is qualified and knowledgeable in law; and
 - one member who by virtue of his or her training is qualified and knowledgeable in economic development and strategies.
- **IV.** The term of office of members of the Board of Directors is three (3) years and is eligible for reappointment.
- **V.** No person shall be appointed a member of the Board if that person:
 - a) is not a citizen of the Republic, and resident in the Province;
 - b) is a Member of Parliament, a Provincial Legislature, a Municipal Council or a House of Traditional leaders established in terms of the Constitution;
 - c) is an un-rehabilitated insolvent;
 - d) is of unsound mind, as declared by a competent court;
 - e) has at any time been convicted of an offence involving dishonesty;
 - f) has at any time been removed from an office of trust on account of misconduct; and
 - g) has previously been removed from the Board for a breach of any provision of this Act.
- **VI.** The nomination must include the following information:
 - a) The full names of the nominee;
 - b) Motivation for the nominee;
 - c) A certified copy of the nominee's identity document;
 - d) Certified copies of the nominee's qualification/s;
 - e) Comprehensive CV of the nominee; and
 - f) A letter of consent from the nominee to serve as a Board member.
- VII. A person may nominate himself or herself;
- VII. Only persons residing in the Province of Gauteng should apply;

The closing date for the nominations is **31 August 2015.**

Applications of nominees received after the closing date will not be considered.
