**HEALTH PROFESSIONS ACT, 1974 (ACT NO. 56 OF 1974)****REGULATIONS RELATING TO THE REGISTRATION BY EMERGENCY CARE  
PRACTITIONERS OF ADDITIONAL QUALIFICATIONS: AMENDMENT**

The Minister of Health intends, under section 35(2) read together with section 61(1)(j) of the Health Professions Act, 1974 (Act No. 56 of 1974) and after consultation with the Health Professions Council of South Africa, to make the Regulations in the Schedule.


Interested persons are invited to submit any substantiated comments in writing on the proposed amendments to the Director-General: Health, Private Bag X828, Pretoria, 0001 (for the attention of the Director: Public Entities Governance), within three months from date of publication of this notice.

**SCHEDULE****Definitions**

1. In these regulations, "Act" means the Health Professions Act, 1974 (Act No. 56 of 1974) any word or expression to which a meaning has been assigned in the Act has the meaning so assigned.

2. The following qualifications held by Emergency Care Practitioners are registrable as additional qualifications under section 35 of the Act:
