Dear Valued Customers,

Government Printing Works has implemented rules for completing and submitting the electronic Adobe Forms when you, the customer, submits your notice request.

Please take note of these guidelines when completing your form.



GPW Business Rules

1. No hand written notices will be accepted for processing, this includes Adobe forms which have been completed by hand.
2. Notices can only be submitted in Adobe electronic form format to the email submission address submit.egazette@gpw.gov.za. This means that any notice submissions not on an Adobe electronic form that are submitted to this mailbox will be **rejected**. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
3. Notices brought into GPW by "walk-in" customers on electronic media can only be submitted in Adobe electronic form format. This means that any notice submissions not on an Adobe electronic form that are submitted by the customer on electronic media will be **rejected**. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
4. All customers who walk in to GPW that wish to submit a notice that is not on an electronic Adobe form will be routed to the Contact Centre where the customer will be taken through the completion of the form by a GPW representative. Where a customer walks into GPW with a stack of hard copy notices delivered by a messenger on behalf of a newspaper the messenger must be referred back to the sender as the submission does not adhere to the submission rules.
5. All notice submissions that do not comply with point 2 will be charged full price for the notice submission.
6. The current cut-off of all Gazette's remains unchanged for all channels. (Refer to the GPW website for submission deadlines – www.gpwonline.co.za)
7. Incorrectly completed forms and notices submitted in the wrong format will be rejected to the customer to be corrected and resubmitted. Assistance will be available through the Contact Centre should help be required when completing the forms. (012-748 6200 or email info.egazette@gpw.gov.za)
8. All re-submissions by customers will be subject to the above cut-off times.
9. All submissions and re-submissions that miss the cut-off will be rejected to the customer to be submitted with a new publication date.
10. Information on forms will be taken as the primary source of the notice to be published. Any instructions that are on the email body or covering letter that contradicts the notice form content will be ignored.

You are therefore advised that effective from **Monday, 18 May 2015** should you not comply with our new rules of engagement, all notice requests will be rejected by our new system.

Furthermore, the fax number **012- 748 6030** will also be **discontinued** from this date and customers will only be able to submit notice requests through the email address submit.egazette@gpw.gov.za.



DO use the new Adobe Forms for your notice request. These new forms can be found on our website: www.gpwonline.co.za under the Gazette Services page.

DO attach documents separately in your email to GPW. (In other words, your email should have an Adobe Form plus proof of payment – 2 separate attachments – where notice content is applicable, it should also be a 3rd separate attachment)

DO specify your requested publication date.

DO send us the electronic Adobe form. (There is no need to print and scan it).

DON'T submit request as a single PDF containing all other documents, i.e. form, proof of payment & notice content, it will be **FAILED** by our new system.

DON'T print and scan the electronic Adobe form.

DON'T send queries or RFQ's to the submit.egazette mailbox.

DON'T send bad quality documents to GPW. (Check that documents are clear and can be read)



Form Completion Rules



- ii. Copy of South African identity document, or copy of valid foreign passport together with a valid work permit that entitles the person to practice Osteopathy in South Africa either under the terms and conditions of employment or in private practice¹;
- iii. All documents must be certified and Council holds the right to call for all original documents in terms of Section 15 of the Act²;
- iv. Any documents submitted in any language other than English must include a sworn translation of the content of the document in English;
- v. All applications must be submitted to the office of the AHPCSA Registrar.

2. Additional Documentation required

- i. Copy of qualification/s in Osteopathy (Bsc (Honours) degree in Osteopathy) from an accredited institution of education and training;
- ii. Original letter from the relevant statutory body in the country of origin certifying the legal standing of the institution of education and training;
- ii. Copy of complete academic record for the full duration of studies;
- iii. SAQA Certificate of Evaluation recognising the legal status of the institution of education and training and evaluation of the qualification/s equal to or above NQF Level 8;
- iv. Original letter of good standing from relevant registering statutory body, which letter must state that the applicant does not have any pending disciplinary proceedings against them or been sanctioned in terms of any disciplinary proceedings. The letter of good standing shall not be older than 3 months;
- v. Police Clearance Certificate from the country of origin;
- vi. If the qualification is older than 5 years the applicant must provide a brief curriculum vitae, in order to establish whether the applicant has been practicing Osteopathy and thereby has kept up to date with the practice and the profession.

3. Application Procedure

- i. Only applications which provide all the details as contained above shall be submitted to the Professional Board for review;
- ii. The AHPCSA Administration will conduct the relevant confirmatory check in respect of work permits with the Department of Home Affairs;
- iii. Applications will be circulated to the Professional Board in .pdf format by way of email for consideration for purposes of registration;
- iv. A combined decision of the Professional Board will be forwarded to the Administration;

¹ In the event of a person not being able to obtain a work permit prior to registration, the Council will provide a letter for such purpose should the applicant meet all the requirements for registration.

- v. If approved for registration, the applicant will be required to successfully complete the AHPCSA's Jurisprudence Assessment, which assessment will be managed by the AHPCSA Administration and provide a valid Level One First Aid Certificate from a service provider accredited with the South African Department of Labour.

4. Applicants who are unable to meet or fail to meet any criteria as stated in paragraphs 2 and 3 above

In the event of:

- i. The evaluation of the institution of education and training by the SAQA is such that the institution is deemed to lack legal standing in the country of origin; or
- ii. The SAQA Certificate of Evaluation is not evaluated equivalent to or higher than the relevant NQF level; or
- iii. There is failure to meet any other requirement as indicated above,

then the application shall be rejected.

CONTINUING PROFESSIONAL DEVELOPMENT

Paragraphs 2.1, 2.3, 2.5 and the final paragraph of Board Notice 85 of 2015, published in the Government Gazette No. 38707 on 24 April 2015, are hereby amended as follows:

1. Paragraph 2.1 is amended to read as follows:

- 2.1 CPD will run over a **two (2) year cycle** with all registered practitioners and therapists in the professions of Ayurveda, Chinese Medicine and Acupuncture, Chiropractic, Homeopathy, Naturopathy, Osteopathy, Phytotherapy, Therapeutic Aromatherapy, Therapeutic Massage Therapy, Therapeutic Reflexology and Unani-Tibb are required to accumulate **forty (40) Continuing Education Units (CEUs) per cycle**;

2. Paragraph 2.3 is amended to read as follows:

2.3 Registered practitioners and therapists in the professions of Ayurveda, Chinese Medicine and Acupuncture, Chiropractic, Homeopathy, Naturopathy, Phytotherapy, Osteopathy, Therapeutic Aromatherapy, Therapeutic Massage Therapy, Therapeutic Reflexology and Unani-Tibb who accumulate more than forty (40) CEU values in a cycle will be permitted to carry over **a maximum of ten (10) CEUs** to the next cycle, with persons registered in multiple professions being allowed to carry over **a maximum of ten (10) CEUs** to the next cycle for the main profession and **a maximum of eight (8) CEUs** for each subsequent registered profession.

3. Paragraph 2.5 is amended to read as follows:

2.5 Registered practitioners and therapists who are registered in more than one (1) Allied Health profession will be required to obtain **forty (40) CEUS** for the main profession and **thirty (30) CEU's per subsequent profession** with a **minimum of two (2) CEUs** for AHPCSA specific jurisprudence and ethics per CPD cycle.

4. The last paragraph is amended to read as follows:

CPD operates on a system of trust and as such any individually registered practitioner or therapist that attend CPD activities in order to comply with the statutory requirements as determined by the AHPCSA shall ensure that he/she is in possession of a certificate of attendance and shall keep such certificates of attendance for a minimum of two (2) justice years after a cycle has ended on record to comply with any random compliance audit.

All customers who walk in to GPW that wish to submit a notice that is not on an electronic Adobe form will be routed to the Contact Centre where the customer will be taken through the completion of the form by a GPW representative. Where a customer walks into GPW with a stack of hard copy notices delivered by a messenger on behalf of a newspaper the messenger must be referred back to the sender as the submission does not adhere to the submission rules.
5. All notice submissions that do not comply with point 2 will be charged full price for the notice submission.
