3. Notices brought into GPW by "walk-in" customers on electronic media can only be submitted in Adobe electronic form format. This means that any notice submissions not on an Adobe electronic form that are submitted by the customer on electronic media will be **rejected**. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
4. All customers who walk in to GPW that wish to submit a notice that is not on an electronic Adobe form will be routed to the Contact Centre where the customer will be taken through the completion of the form by a GPW representative. DEPARTMENT OF JUSTICE AND CONSTITUTIONAL DEVELOPMENT**NOTICE 878 OF 2015****INVITATION TO COMMENT ON THE CYBERCRIMES AND CYBERSECURITY BILL:
DEADLINE FOR COMMENT 30 NOVEMBER 2015**

1. The draft Cybercrimes and Cybersecurity Bill (hereinafter referred to as “the Bill”) aims to deal with various aspects relating to cybercrime and cybersecurity and to that extent the Bill -

- * creates offences and prescribes penalties;
- * further regulates jurisdiction;
- * further regulates the powers to investigate, search and gain access to or seize items;
- * further regulates aspects of international cooperation in respect of the investigation of cybercrime;
- * provides for the establishment of a 24/7 point of contact;
- * provides for the establishment of various structures to deal with cyber security;
- * regulates the identification and declaration of National Critical Information Infrastructures and provides for measures to protect National Critical Information Infrastructures;
- * further regulates aspects relating to evidence;
- * imposes obligations on electronic communications service providers regarding aspects which may impact on cybersecurity;
- * provides that the President may enter into agreements with foreign States to promote cybersecurity;
- * repeals and amends certain laws; and
- * provides for matters connected therewith.
