#### GPW Business Rules

2. Notices can only be submitted in Adobe electronic form format to the email submission address [submit.egazette@gpw.gov.za](mailto:submit.egazette@gpw.gov.za). This means that any notice submissions not on an Adobe electronic form that are submitted to this mailbox will be **rejected**. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
3. Notices brought into GPW by "walk-in" customers on electronic media can only be submitted in Adobe electronic form format. This means that any notice submissions not on an Adobe electronic form that are submitted by the customer on electronic media will be **rejected**. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
4. All customers who walk in to GPW that wish to submit a notice that is not on an electronic Adobe form will be routed to the Contact Centre where the customer will be taken through the completion of the form by a GPW representative. Where a customer walks into GPW with a stack of hard copy notices delivered by a messenger on behalf of a newspaper the messenger must be referred back to the sender as the submission does not adhere to the submission rules.
5. All notice submissions that do not comply with point 2 will be charged full price for the notice submission.
6. The current cut-off of all Gazette's remains unchanged for all channels. (Refer to the GPW website for submission deadlines – [www.gpwonline.co.za](http://www.gpwonline.co.za))
7. Incorrectly completed forms and notices submitted in the wrong format will be rejected to the customer to be corrected and resubmitted. 8. All re-submissions by customers will be subject to the above cut-off times.

**PROFESSIONAL BOARD: HOMEOPATHY, NATUROPATHY AND PHYTOTHERAPY  
UNPROFESSIONAL CONDUCT: INSTITUTION OF A DISCIPLINARY INQUIRY: COMPOSITION  
OF INQUIRING BODY**

The Allied Health Professions Council of South Africa, after due consideration and in consultation with the Professional Board: Homeopathy, Naturopathy and Phytotherapy (PBHNP), has resolved in terms of Regulation 19 of Regulations No.R.2610 of 3 December 1982 that where the PBHNP appoints a committee and delegates powers to such committee to act as an *inquiring body*, that said committee shall be composed of at least -

- (a) *two public representatives, one of whom must be a chairperson;*
- (b) *two persons registered in the profession in which the respondent is registered, at least one of whom is registered in the same discipline as the respondent;*
- (c) *one member of the Council; and*
- (d) *one legal assessor.*
