Dear Valued Customers,

Government Printing Works has implemented rules for completing and submitting the electronic Adobe Forms when you, the customer, submits your notice request.

Please take note of these guidelines when completing your form.



GPW Business Rules

1. No hand written notices will be accepted for processing, this includes Adobe forms which have been completed by hand.
2. Notices can only be submitted in Adobe electronic form format to the email submission address submit.egazette@gpw.gov.za. This means that any notice submissions not on an Adobe electronic form that are submitted to this mailbox will be **rejected**. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
3. Notices brought into GPW by "walk-in" customers on electronic media can only be submitted in Adobe electronic form format. This means that any notice submissions not on an Adobe electronic form that are submitted by the customer on electronic media will be **rejected**. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
4. All customers who walk in to GPW that wish to submit a notice that is not on an electronic Adobe form will be routed to the Contact Centre where the customer will be taken through the completion of the form by a GPW representative. Where a customer walks into GPW with a stack of hard copy notices delivered by a messenger on behalf of a newspaper the messenger must be referred back to the sender as the submission does not adhere to the submission rules.
5. All notice submissions that do not comply with point 2 will be charged full price for the notice submission.
6. The current cut-off of all Gazette's remains unchanged for all channels. (Refer to the GPW website for submission deadlines – www.gpwonline.co.za)
7. Incorrectly completed forms and notices submitted in the wrong format will be rejected to the customer to be corrected and resubmitted. Assistance will be available through the Contact Centre should help be required when completing the forms. (012-748 6200 or email info.egazette@gpw.gov.za)
8. All re-submissions by customers will be subject to the above cut-off times.
9. All submissions and re-submissions that miss the cut-off will be rejected to the customer to be submitted with a new publication date.
10. Information on forms will be taken as the primary source of the notice to be published. Any instructions that are on the email body or covering letter that contradicts the notice form content will be ignored.

You are therefore advised that effective from **Monday, 18 May 2015** should you not comply with our new rules of engagement, all notice requests will be rejected by our new system.

Furthermore, the fax number **012- 748 6030** will also be **discontinued** from this date and customers will only be able to submit notice requests through the email address submit.egazette@gpw.gov.za.

The Head of the Department of Transport hereby makes known, in terms of section 27(3)(c) of the South African National Roads Agency Limited and National Roads Act, 1998 (Act No. 7 of 1998), that the Minister of Transport has, in terms of section 27(3)(a) of that Act and on the recommendation of the South African National Roads Agency SOC Ltd, determined that the provisions of Table 1 insofar as Column 6 (Alternative User Tariff) is concerned and paragraph 5.18 of Government Notice 524 of 17 June 2015 (the Government Notice) as corrected by Government Notice 579 of 1 July 2015 be amended and paragraph 5.18A be withdrawn as shown in the Schedule hereto.

The Minister of Transport has also determined, on the recommendation of the South African National Roads Agency SOC Ltd and in terms of section 27(3)(d) of the Act, that the tolls (shown in Column 6) that may be levied in terms of this Notice, will be effective for all transactions governed by the Government Notice as from 1 September 2015.

2 Amendment of paragraph 5.18 of the Government Notice

The following paragraph is substituted for paragraph 5.18 of the Government Notice:

“Discounts for alternate users after the grace period

- 5.18 An alternate user who pays an e-toll transaction after the grace period and within 30 days of the date of the invoice, will be granted a discount, at the time of payment, such that after such discount is applied the alternate user will, in respect of an invoice where payment is made in full, receive a discount equal to 50 % of the tariff set out in Column 6 of Table 1.”

3. Withdrawal of paragraph 5.18A of the Government Notice

Paragraph 5.18A of the Government Notice is hereby withdrawn.

MEMORANDUM

AMENDMENT TO TOLL TARIFF NOTICE FOR THE GAUTENG FREEWAY IMPROVEMENT PROJECT

An updated toll tariff notice was published for comment on 27 August 2015 to allow the public to comment on the new toll tariffs and discounts and to implement further features of the New Dispensation that was announced by Government in May 2015.

As an interim measure the existing toll tariff notice is amended, based on comments received, to allow for a reduced alternate user tariff of double the standard tariff that becomes applicable if no payment was made during the grace period, and a 50% discount if payment is made within 30 days of the date of an invoice for unpaid tolls.

Previously, the alternate tariff amounted to three times the standard tariff. In terms of this tariff notice, it will amount to two times the standard tariff. The discount if payment is made within 30 days of the date of invoice is now 50% as opposed to the previous 60%. This adjustment gives further effect to the benefits of the New Dispensation, since the net effect if payment is made within 30 days of the date of the invoice results in a lower tariff payable by the road user.

In order to illustrate the net effect of this amendment, the following example is provided for a typical toll transaction:

These provisions will apply to all transactions from 1 September 2015.

3. Notices brought into GPW by "walk-in" customers on electronic media can only be submitted in Adobe electronic form format. This means that any notice submissions not on an Adobe electronic form that are submitted by the customer on electronic media will be **rejected**. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
4. All customers who walk in to GPW that wish to submit a notice that is not on an electronic Adobe form will be routed to the Contact Centre where the customer will be taken through the completion of the form by a GPW representative. Where a customer walks into GPW with a stack of hard copy notices delivered by a messenger on behalf of a newspaper the messenger must be referred back to the sender as the submission does not adhere to the submission rules.
5. All notice submissions that do not comply with point 2 will be charged full price for the notice submission.
6. The current cut-off of all Gazette's remains unchanged for all channels. (Refer to the GPW website for submission deadlines – www.gpwonline.co.za)
7. Incorrectly completed forms and notices submitted in the wrong format will be rejected to the customer to be corrected and resubmitted. Assistance will be available through the Contact Centre should help be required when completing the forms. (012-748 6200 or email info.egazette@gpw.gov.za)
8. All re-submissions by customers will be subject to the above cut-off times.
9. All submissions and re-submissions that miss the cut-off will be rejected to the customer to be submitted with a new publication date.
10. Information on forms will be taken as the primary source of the notice to be published. Any instructions that are on the email body or covering letter that contradicts the notice form content will be ignored.

You are therefore advised that effective from **Monday, 18 May 2015** should you not comply with our new rules of engagement, all notice requests will be rejected by our new system.
