

Government Printing Works has implemented rules for completing and submitting the electronic Adobe Forms when you, the customer, submits your notice request.

Please take note of these guidelines when completing your form.

GPW Business Rules

1. No hand written notices will be accepted for processing, this includes Adobe forms which have been completed by hand.



- 3. Notices brought into GPW by "walk-in" customers on electronic media can only be submitted in Adobe electronic form format. This means that any notice submissions not on an Adobe electronic form that are submitted by the customer on electronic media will be <u>rejected</u>. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
- 4. All customers who walk in to GPW that wish to submit a notice that is not on an electronic Adobe form will be routed to the Contact Centre where the customer will be taken through the completion of the form by a GPW representative. Where a customer walks into GPW with a stack of hard copy notices delivered by a messenger on behalf of a newspaper the messenger must be referred back to the sender as the submission does not adhere to the submission rules.
- 5. All notice submissions that do not comply with point 2 will be charged full price for the notice submission.
- 6. The current cut-off of all Gazette's remains unchanged for all channels. (Refer to the GPW website for submission deadlines www.gpwonline.co.za)
- 7. Incorrectly completed forms and notices submitted in the wrong format will be rejected to the customer to be corrected and resubmitted. Assistance will be available through the Contact Centre should help be required when completing the forms. (012-748 6200 or email info.egazette@gpw.gov.za)
- 8. All re-submissions by customers will be subject to the above cut-off times.
- 9. All submissions and re-submissions that miss the cut-off will be rejected to the customer to be submitted with a new publication date.
- 10. Information on forms will be taken as the primary source of the notice to be published. Any instructions that are on the email body or covering letter that contradicts the notice form content will be ignored.

You are therefore advised that effective from **Monday**, **18 May 2015** should you not comply with our new rules of engagement, all notice requests will be rejected by our new system.

THE SOUTH AFRICAN NATIONAL ROADS AGENCY LIMITED AND NATIONAL ROADS ACT, 1998 (ACT No. 7 OF 1998): GAUTENG FREEWAY IMPROVEMENT PROJECT

The Head of the Department of Transport hereby makes known that the Minister of Transport has, on the recommendation of the South African National Roads Agency SOC Ltd (the "Agency"), determined the date, as contemplated in Government Notice No. 524 of 17 June 2015, on which the once-off discount for payment of outstanding tolls on the GFIP toll roads will become operative. The date on which this will become operative is set out in the schedule hereto.

Schedule

- 1. In terms of Government Gazette No. 524 of 17 June 2015, the Minister announced that
 - a. "the provisions of paragraphs 5.20 to 5.23 of the Schedule shall not come into operation on the Effective Date and shall only become operative from a date subsequently determined by the Minister and made known by the Minister in the Gazette.";
 - b. the once-off discount shall apply where payment is "paid in full by no later than such date and time as subsequently determined by the Minister and is made known by the Minister in the Gazette".
- 2. The dates and information referred to in Paragraph 1 above are as follows:
 - a. The date on which the once-off 60% discount becomes operative shall be 2 November 2015:
 - b. The once-off 60% discount shall apply for a period of 6 (six) months until 23:59 on 2 May 2016.
- 3. The Minister has further determined, on the recommendation of the Agency, that the aforementioned discount shall apply to all unpaid tolls levied in respect of e-toll transactions on the GFIP toll roads, up to and including 31 August 2015.

 - b. Die eenmalige afslag van toepassing sal wees waar betaling "ten volle betaal word teen nie later as sodanige datum en tyd soos deur die Minister bepaal en bekend gemaak word in die Staatskoerant nie"
