SCHEDULE

(1) Addition of "bulk SMS/MMS service" definition:

"Bulk Short Message Service (SMS)\ Multi Media Service (MMS) service" means a subset service of Machine Related services (MRS) which comprises of communication, sent in large volumes, that originates from a device or machine to persons;"

(2) Addition of sub regulation (2) and (3) of regulation 24:

"(2) Bulk SMS/MMS services, which are offered from previously allocated numbers are exempt from the migration."

"(3) Future assignments for bulk SMS/MMS services, that extend beyond the numbering capacities reserved and provisioned by providers, must be in the designated numbering range for MRS."

(3) Substitution of clause (2) (9)(f) of Schedule 1 of the Regulations:

"(f) Codes for government services, emergency services (24 hour response) and non-profit organizations

(i) These codes are used to access emergency services with a 24 hour response function and non-profit organizations, pursuant to regulation 13(2). The following short codes are designated for such services:

- **115 xxx** (total of 1000 codes)
- **116 xxx** (total of 1000 codes)
- **128 xxx** (total of 1000 codes)
- **129 xxx** (total of 1000 codes)

(ii) Government services

- **144 xxx** (total of 1000 codes)
- **145 xxx** (total of 1000 codes)
- **148 xxx** (total of 1000 codes)

- (iii) The short codes below are reserved for the designated provincial offices as shown on table 2. These codes shall hence be allocated to the respective licensees which have acquired permissions to provide such electronic communication services of each provincial office.
