Government Printing Works has implemented rules for completing and submitting the electronic Adobe Forms when you, the customer, submits your notice request.

Please take note of these guidelines when completing your form.

GPW Business Rules

1. No hand written notices will be accepted for processing, this includes Adobe forms which have been completed by hand.



- Notices can only be submitted in Adobe electronic form format to the email submission address <u>submit.egazette@gpw.gov.za</u>. This means that any notice submissions not on an Adobe electronic form that are submitted to this mailbox will be <u>rejected</u>. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
- 3. Notices brought into GPW by "walk-in" customers on electronic media can only be submitted in Adobe electronic form format. This means that any notice submissions not on an Adobe electronic form that are submitted by the customer on electronic media will be <u>rejected</u>. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
- 4. All customers who walk in to GPW that wish to submit a notice that is not on an electronic Adobe form will be routed to the Contact Centre where the customer will be taken through the completion of the form by a GPW representative. Where a customer walks into GPW with a stack of hard copy notices delivered by a messenger on behalf of a newspaper the messenger must be referred back to the sender as the submission does not adhere to the submission rules.
- 5. All notice submissions that do not comply with point 2 will be charged full price for the notice submission.
- 6. The current cut-off of all Gazette's remains unchanged for all channels. (Refer to the GPW website for submission deadlines <u>www.gpwonline.co.za</u>)
- 7. Incorrectly completed forms and notices submitted in the wrong format will be rejected to the customer to be corrected and resubmitted. Assistance will be available through the Contact Centre should help be required when completing the forms. (012-748 6200 or email <u>info.egazette@gpw.gov.za</u>)
- 8. All re-submissions by customers will be subject to the above cut-off times.
- 9. All submissions and re-submissions that miss the cut-off will be rejected to the customer to be submitted with a new publication date.
- 10. Information on forms will be taken as the primary source of the notice to be published. Any instructions that are on the email body or covering letter that contradicts the notice form content will be ignored.

You are therefore advised that effective from **Monday**, **18 May 2015** should you not comply with our new rules of engagement, all notice requests will be rejected by our new system.

Furthermore, the fax number **012-748 6030** will also be <u>discontinued</u> from this date and customers will only be able to submit notice requests through the email address <u>submit.egazette@gpw.gov.za</u>.

APPLICATION BY SMART VILLAGE FOR THE TRANSFER OF CONTROL OF ITS INDIVIDUAL ELECTRONIC COMMUNICATIONS SERVICE (I-ECS) LICENCE AND INDIVIDUAL ELECTRONIC COMMUNICATIONS NETWORK SERVICE (I-ECNS) LICENCE FROM MULTICHOICE SOUTH AFRICA (PTY) LTD TO MTN SA (PTY) LTD

- 1 The Independent Communications Authority of South Africa ("the Authority") was established in terms of section 2 of the Independent Communications Authority Act, 13 of 2000 ("ICASA Act"), as amended
- 2 Application
- 2.1 On 05 November 2015, the Authority received an application from Smart Village (Pty) LTD (Smart Village) a wholly owned subsidiary of Multichoice South Africa (Pty) LTD (Multichoice) for the transfer of control of its I-ECS and I-ECNS licences from Multichoice to MTN SA (Pty) LTD.
- 2.2 The Application is made in terms of section 13 read with section 9 (2) to (6) of the Electronic Communications Act, 36 of 2005 ("ECA"), as amended.
- 2.3 Applications submitted to the Authority are;
 - 2.3.1 Smart Village Proprietary Limited ("Smart Village"), I-ECS licensee 0298/IECS/MAR/09 applied to transfer 100% of control of ownership of its I-ECS licence to MTN SA Proprietary Limited ("MTN").

- 2.3.2 Smart Village Proprietary Limited ("Smart Village"), I-ECNS licensee 0298/IECNS/MAR/09 applied to transfer 100% of control of ownership its I-ECNS licence to MTN SA Proprietary Limited ("MTN").
- 2.4 Section 9 (2) (a) of the ECA states that the Authority "must give notice of the application in the gazette and invite interested persons to apply and submit written representations in relation to the application within the period mentioned in the notice".

3 Process

- 3.1 The Authority hereby calls upon any interested person to submit written representations to the application by Smart Village for the transfer of control of its I-ECS and I-ECNS licences by <u>4pm (SAST) on Wednesday</u> <u>27 January 2016.</u>
- 3.2 The Application, and any representations received pursuant thereto will be made available and open for inspection by interested parties in the Authority's website and library, during office hours.
- 3.3 Any person who submits written representations must indicate whether they require an opportunity to make oral representations in the event that the Authority opts to hold public hearings.
