Non-compliance to these deadlines will result in your request being failed. **Please pay special attention to the different deadlines for each gazette.**

Please note that any notices cancelled after the cancellation deadline will be published and charged at full cost.

Requests for cancellation must be sent by the original sender of the notice and must be accompanied by the relevant notice reference number (N-) in the email body.

AMENDMENTS TO NOTICES

With effect from 01 October, GPW will not longer accept amendments to notices. The cancellation process will need to be followed and a new notice submitted thereafter for the next available publication date.

When submitting your notice request to submit.egazette@gpw.gov.za, please ensure that a purchase order (GPW Account customer) or proof of payment (non-GPW Account customer) is included with your notice submission. All documentation relating to the notice submission must be in a single email.

A reminder that documents must be attached separately in your email to GPW. (In other words, your email should have an Adobe Form plus proof of payment/purchase order – 2 separate attachments – where notice content is applicable, it should also be a 3rd separate attachment).

REMINDER OF THE GPW BUSINESS RULES

- Single notice, single email – with proof of payment or purchase order.
- All documents must be attached separately in your email to GPW.
- 1 notice = 1 form, i.e. each notice must be on a separate form
- Please submit your notice **ONLY ONCE**.
- Requests for information, quotations and inquiries must be sent to the Contact Centre **ONLY**.
- The notice information that you send us on the form is what we publish. Please do not put any instructions in the email body.

SMALL CLAIMS COURTS ACT, 1984 (ACT NO. 61 OF 1984)

ESTABLISHMENT OF SMALL CLAIMS COURTS FOR THE AREAS OF THE LIMPOPO
PROVINCE AND MPUMALANGA PROVINCE

I, John Harold Jeffery, Deputy Minister of Justice and Constitutional Development, acting under the power delegated to me by the Minister of Justice and Correctional Services, hereby, with effect from 25 January 2016—

- (a) in terms of section 2(1)(e) of the Small Claims Courts Act, 1984 (Act No. 61 of 1984), withdraw the Government Notices mentioned in Column A of the Schedule;
- (b) in terms of section 2(1)(a) of the said Act, establish the small claims courts mentioned in Column B of the Schedule for the areas mentioned in Column C of the Schedule;
- (c) in terms of section 2(1)(aA) of the said Act, determine the seats of such small claims courts, established in terms of paragraph (b), as is mentioned opposite thereto in Column D of the Schedule, and
- (d) in terms of section 2(1)(b) of the said Act, determine the places in the areas concerned for the holding of sessions of the courts established in terms of paragraph (b) as mentioned opposite thereto in Column E of the Schedule.

Despite the withdrawal of the Government Notices mentioned in Column A of the Schedule, any claim which has already been instituted in a small claims court which has jurisdiction to adjudicate the matter, shall be continued and concluded as if this Government Notice has not been published.
