## Notice submission deadlines

Government Printing Works has over the last few months implemented rules for completing and submitting the electronic Adobe Forms when you, the customer, submit your notice request.

In line with these business rules, GPW has revised the notice submission deadlines for all gazettes. Please refer to the GPW website [www.gpwonline.co.za](http://www.gpwonline.co.za) to familiarise yourself with the new deadlines.

### CANCELLATIONS

Don't forget!

Cancellation of notice submissions are accepted by GPW according to the deadlines stated in the table above.

Non-compliance to these deadlines will result in your request being failed. **Please pay special attention to the different deadlines for each gazette.**

**Please note that any notices cancelled after the cancellation deadline will be published and charged at full cost.**

Requests for cancellation must be sent by the original sender of the notice and must be accompanied by the relevant notice reference number (N-) in the email body.

### AMENDMENTS TO NOTICES

take note!

With effect from 01 October, GPW will not longer accept amendments to notices. The cancellation process will need to be followed and a new notice submitted thereafter for the next available publication date.

### CUSTOMER INQUIRIES



Many of our customers request immediate feedback/confirmation of notice placement in the gazette from our Contact Centre once they have submitted their notice – While GPW deems it one of their highest priorities and responsibilities to provide customers with this requested feedback and the best service at all times, we are only able to do so once we have started processing your notice submission.

GPW has a **2-working day turnaround time for processing notices** received according to the business rules and deadline submissions.

Please keep this in mind when making inquiries about your notice submission at the Contact Centre.

### PROOF OF PAYMENTS



GPW reminds you that all notice submissions **MUST** be submitted with an accompanying proof of payment (PoP) or purchase order (PO). If any PoP's or PO's are received without a notice submission, it will be failed and your notice will not be processed.

When submitting your notice request to [submit.egazette@gpw.gov.za](mailto:submit.egazette@gpw.gov.za), please ensure that a purchase order (GPW Account customer) or proof of payment (non-GPW Account customer) is included with your notice submission. All documentation relating to the notice submission must be in a single email.

A reminder that documents must be attached separately in your email to GPW. (In other words, your email should have an Adobe Form plus proof of payment/purchase order – 2 separate attachments – where notice content is applicable, it should also be a 3rd separate attachment).

### REMINDER OF THE GPW BUSINESS RULES

- Single notice, single email – with proof of payment or purchase order.
- All documents must be attached separately in your email to GPW.
- 1 notice = 1 form, i.e. each notice must be on a separate form
- Please submit your notice **ONLY ONCE**.
- Requests for information, quotations and inquiries must be sent to the Contact Centre **ONLY**.
- The notice information that you send us on the form is what we publish. Please do not put any instructions in the email body.



The Independent Communications Authority of South Africa (“the Authority”) hereby issues notice that it has received three (3) applications for MUX 3 radio frequency spectrum licence in response to the Invitation To Apply published on 10 September 2015 in Government Gazette No. 39191. 2. All applications are available for inspection by any interested persons at the ICASA library, Block D, Pinmill Farm, 164 Katherine Street, Sandton, during the Authority’s normal office hours.
3. Interested persons are invited to submit written representations in relation to the applications to the Authority for attention of Mr. Busang Sethole, Project Manager at Block A, Pinmill Farm, 164 Katherine Street, Sandton or by fax no: (011) 566 3290 or by email [bsethole@icasa.org.za](mailto:bsethole@icasa.org.za) within twenty one (21) working days of the date of publication of this notice.
4. Persons who make representations must indicate in their written representations whether they require an opportunity to make oral representations in the event the Authority decides to hold public hearings.
5. Persons who submit representations in terms of this notice shall, when submitting such representations, provide proof to the satisfaction of the Authority that a copy of

the representations submitted has also been sent by registered mail, e-mail or by facsimile or delivered by hand to the contact person of the applicant as mentioned in **SCHEDULE A**.

6. The applicant shall be entitled to respond in writing to the written representations made by any interested persons, and such written response must be lodged with the Authority within twenty one (21) working days after the closing date of the written representation. The applicant must, at the time of lodging such written response, furnish to the Authority's satisfaction that it has delivered a copy of such response by hand or has sent a copy of such response by registered mail, e-mail or facsimile to the relevant person having made such written representation.
