## CANCELLATIONS



Cancellation of notice submissions are accepted by GPW according to the deadlines stated in the table above. Non-compliance to these deadlines will result in your request being failed. Please pay special attention to the different deadlines for each gazette.

Please note that any notices cancelled after the cancellation deadline will be published and charged at full cost.

Requests for cancellation must be sent by the original sender of the notice and must accompanied by the relevant notice reference number (N-) in the email body.

# AMENOMENTS TO NOTICES



With effect <u>from 01 October</u>, GPW will not longer accept amendments to notices. The cancellation process will need to be followed and a new notice submitted thereafter for the next available publication date.

# CUSTOMER INQUIRIES

# PROOF OF PAYMENTS REMINDER

When submitting your notice request to <a href="mailto:submit.egazette@gpw.gov.za">submit.egazette@gpw.gov.za</a>, please ensure that a purchase order (GPW Account customer) or proof of payment (non-GPW Account customer) is included with your notice submission. All documentation relating to the notice submission must be in a single email.

A reminder that documents must be attached separately in your email to GPW. (In other words, your email should have an Adobe Form plus proof of payment/purchase order – 2 separate attachments – where notice content is applicable, it should also be a 3rd separate attachment).

### REMINDER OF THE GPW BUSINESS RULES

- ☐ Single notice, single email with proof of payment or purchase order.
- All documents must be attached separately in your email to GPW.
- 1 notice = 1 form, i.e. each notice must be on a separate form
- ☐ Please submit your notice **ONLY ONCE.**
- Requests for information, quotations and inquiries must be sent to the Contact Centre ONLY.
- The notice information that you send us on the form is what we publish. Please do not put any instructions in the email body.

### NATIONAL HEALTH ACT, 2003

REGULATIONS REGARDING THE GENERAL CONTROL OF HUMAN BODIES, TISSUE, BLOOD, BLOOD PRODUCTS AND GAMETES: AMENDMENT

The Minister of Health intends, under section 90(1) read with section 68(1), section 56(1) ad 56(2)(ii) of the National Health Act, 2003 (Act No. 61 of 2003) made regulations in the Schedule.

Interested persons are invited to submit any substantiated comments or representations in writing on the proposed amendments to the Director-General: Health, Private Bag X 828, Pretoria, 0001(for the attention of Ms P Netshidzivhani), within one month from the date of this notice.

#### **SCHEDULE**

### **Definitions**

1. In these regulations "the regulations" means the Regulations regarding the general control of human bodies, tissue, blood, blood products and gametes published under Government Gazette No. 35099, Government Notice No. R180 of 02 March 2012

### **Amendment of Regulation 2**

Regulation 2 is hereby amended by substitution of the following:-

#### Consent for the removal of tissue, blood and gametes from living persons

- 2 (1) A person may not remove tissue, blood or gametes from the body of another living person for a purpose referred to in section 56 and regulation 3 unless written consent thereto has been granted as follows -
  - (a) where such person is older than 18 years, by that person;
  - (b) where such a person is younger than 18 years, by the parents or guardians of that person;
- (2) A person may not remove blood from the body of another living person for a purpose referred to in section 56 and regulation 3 unless written consent thereto has been granted by a person older than 16 years.
