1. The *Government Gazette* and *Government Tender Bulletin* are weekly publications that are published on Fridays and the closing time for the acceptance of notices is strictly applied according to the scheduled time for each gazette.

All re-submissions will be subject to the standard cut-off times.

GOVERNMENT PRINTING WORKS - BUSINESS RULES**NOTICE SUBMISSION PROCESS**

3. Download the latest *Adobe* form, for the relevant notice to be placed, from the **Government Printing Works** website www.gpwonline.co.za.
4. The *Adobe* form needs to be completed electronically using *Adobe Acrobat / Acrobat Reader*. Only electronically completed *Adobe* forms will be accepted. No printed, handwritten and/or scanned *Adobe* forms will be accepted.
5. The completed electronic *Adobe* form has to be submitted via email to submit.egazette@gpw.gov.za. The form needs to be submitted in its original electronic *Adobe* format to enable the system to extract the completed information from the form for placement in the publication.
6. Each notice submission should be sent as a single email. The email should contain **all documentation relating to a particular notice submission**, each as a separate attachment:
 - 6.1. Electronically completed *Adobe* form, specific to the type of notice that is to be placed.
 - 6.1.1. For National *Government Gazette* or *Provincial Gazette* notices, the notices must be accompanied by an electronic Z95 or Z95Prov *Adobe* form
 - 6.1.2. The notice content (body copy) **MUST** be a separate attachment.
 - 6.2. Proof of Payment / Purchase Order: **Government Printing Works** account customer must include a copy of their Purchase Order. **Non-Government Printing Works** account customer needs to submit the proof of payment for the notice
 - 6.3. Where separate notice content is applicable (Z95, Z95 Prov and TForm 3, it should also be attached as a separate attachment. (See specifications below, point 11).
 - 6.4. Any additional notice information if applicable.
7. The electronic *Adobe* form will be taken as the primary source for the notice information to be published. Instructions that are on the email body or covering letter that contradicts the notice form content will not be considered. The information submitted on the electronic *Adobe* form will be published as-is.
8. To avoid duplicated publication of the same notice and double billing, Please submit your notice **ONLY ONCE**.
9. Notices brought to **GPW** by "walk-in" customers on electronic media can only be submitted in *Adobe* electronic form format. All "walk-in" customers with notices that are not on electronic *Adobe* forms will be routed to the Contact Centre where they will be assisted to complete the forms in the required format.
10. Should a customer submit a bulk submission of hard copy notices delivered by a messenger on behalf of any organisation e.g. newspaper publisher, the messenger will be referred back to the sender as the submission does not adhere to the submission rules.

11. Where the copy is part of a separate attachment document for Z95, Z95Prov and TForm03
 - 11.1. Copy of notices must be supplied in a separate document and may not constitute part of any covering letter, purchase order, proof of payment or other attached documents.

The content document should contain only one notice. (You may include the different translations of the same notice in the same document).
 - 11.2. The notice should be set on an A4 page, with margins and fonts set as follows:

Page size = A4 Portrait with page margins: Top = 40mm, LH/RH = 16mm, Bottom = 40mm;
Use font size: Arial or Helvetica 10pt with 11pt line spacing;

Page size = A4 Landscape with page margins: Top = 16mm, LH/RH = 40mm, Bottom = 16mm;
Use font size: Arial or Helvetica 10pt with 11pt line spacing;

CANCELLATIONS

12. Cancellation of notice submissions are accepted by **GPW** according to the deadlines stated in the table above in point 2. Non-compliance to these deadlines will result in your request being failed. Please pay special attention to the different deadlines for each gazette. Please note that any notices cancelled after the cancellation deadline will be published and charged at full cost.
13. Requests for cancellation must be sent by the original sender of the notice and must be accompanied by the relevant notice reference number (N-) in the email body.

AMENDMENTS TO NOTICES

14. With effect from 01 October 2015, **GPW** will not longer accept amendments to notices. The cancellation process will need to be followed according to the deadline and a new notice submitted thereafter for the next available publication date.

REJECTIONS

15. All notices not meeting the submission rules will be rejected to the customer to be corrected and resubmitted. Assistance will be available through the Contact Centre should help be required when completing the forms. (012-748 6200 or email info.egazette@gpw.gov.za). Reasons for rejections include the following:
 - 15.1. Incorrectly completed forms and notices submitted in the wrong format, will be rejected.
 - 15.2. Any notice submissions not on the correct *Adobe* electronic form, will be rejected.
 - 15.3. Any notice submissions not accompanied by the proof of payment / purchase order will be rejected and the notice will not be processed.
 - 15.4. Any submissions or re-submissions that miss the submission cut-off times will be rejected to the customer. The Notice needs to be re-submitted with a new publication date.

GOVERNMENT PRINTING WORKS - BUSINESS RULES**APPROVAL OF NOTICES**

16. Any notices other than legal notices are subject to the approval of the Government Printer, who may refuse acceptance or further publication of any notice.
17. No amendments will be accepted in respect to separate notice content that was sent with a Z95 or Z95Prov notice submissions. The copy of notice in layout format (previously known as proof-out) is only provided where requested, for Advertiser to see the notice in final Gazette layout. Should they find that the information submitted was incorrect, they should request for a notice cancellation and resubmit the corrected notice, subject to standard submission deadlines. The cancellation is also subject to the stages in the publishing process, i.e. If cancellation is received when production (printing process) has commenced, then the notice cannot be cancelled.

GOVERNMENT PRINTER INDEMNIFIED AGAINST LIABILITY

18. The Government Printer will assume no liability in respect of—
 - 18.1. any delay in the publication of a notice or publication of such notice on any date other than that stipulated by the advertiser;
 - 18.2. erroneous classification of a notice, or the placement of such notice in any section or under any heading other than the section or heading stipulated by the advertiser;

PAYMENT OF COST

23. Payment should then be made, or Purchase Order prepared based on the received quotation, prior to the submission of the notice for advertising as these documents i.e. proof of payment or Purchase order will be required as part of the notice submission, as indicated earlier.
24. THE SOUTH AFRICAN NATIONAL ROADS AGENCY LIMITED AND NATIONAL ROADS ACT, 1998 (ACT NO. 7 OF 1998)**REGULATIONS ON EXEMPTION FROM AND REBATES ON THE PAYMENT OF TOLLS**

I, Elizabeth Dipuo Peters, the Minister of Transport hereby, in terms of section 58(1)(dA) and (dC) of The South African National Roads Agency Limited and National Roads Act, 1998 (Act No. 7 of 1998) and after consultation with the Agency, make the regulations in the Schedule hereto.

SCHEDULE**Definitions**

1. In these Regulations, any word or expression to which a meaning has been assigned in the Act, the National Land Transport Act or the e-Road Regulations shall have the same meaning and, unless the context indicates otherwise—

“e-Road Regulations” means the e-Road Regulations, 2013 made by the Minister under section 58(1)(dA) and (dC) of the Act;

“exempt adapted vehicle” means a motor vehicle that is specially adapted for use by or to be driven by persons with disabilities;

“exempt ambulance” means an ambulance registered as such in terms of the National Road Traffic Act and marked as an ambulance and that has been exempted by the Agency, in terms of section 27(1)(c) of the Act, from the liability to pay e-toll on an e-road or any portion of an e-road;

“exempt emergency medical response vehicle” means an emergency medical response vehicle used only for medical response purposes that is registered as such in terms of the National Road Traffic Act and that has been exempted by the Agency, in terms of section 27(1)(c) of the Act, from the liability to pay e-toll on an e-road or any portion of an e-road;

“exempt fire-fighting vehicle” means a fire-fighting vehicle registered in terms of the National Road Traffic Act and marked as a fire-fighting vehicle and that has been exempted by the Agency, in terms of section 27(1)(c) of the Act, from the liability to pay e-toll on an e-road or any portion of an e-road;

“exempt NGO vehicle” means a motor vehicle owned or used by a qualifying non-government organisation (NGO) that is used for conveying persons with disabilities or for the purposes of health care, welfare or humanitarian purposes or education and development and that is exempted by the Agency, in terms of section 27(1)(c) of the Act, from the liability to pay e-toll on an e-road or any portion of an e-road;

“exempt NPO vehicle” means a motor vehicle owned or used by a qualifying non-profit organisation (NPO) that is used for conveying persons with disabilities or for the purposes of health care, welfare or humanitarian purposes or education and development and that is exempted by the Agency, in terms of section 27(1)(c) of the Act, from the liability to pay e-toll on an e-road or any portion of an e-road;

“exempt public transport vehicle” means a motor vehicle that provides a public transport service and that is exempted by the Agency, in terms of section 27(1)(c) of the Act, from the liability to pay e-toll on an e-road or any portion of an e-road;

“exempt rescue vehicle” means a rescue vehicle used only for the purpose of rescuing persons that is registered as a rescue vehicle in terms of the National Road Traffic Act and that has been exempted by the Agency, in terms of section 27(1)(c) of the Act, from the liability to pay e-toll on an e-road or any portion of an e-road;

“exempt traffic officer vehicle” means a vehicle used by a traffic officer as defined in section 1 of the National Road Traffic Act and marked as a traffic officer vehicle and that has been exempted by the Agency, in terms of section 27(1)(c) of the Act, from the liability to pay e-toll on an e-road or any portion of an e-road;

“**GFIP toll-roads**” means the roads declared for the Gauteng Freeway Improvement Project as specified in the relevant exemptions or rebates published by the Minister or the Agency in relation to that Project;

“**National Land Transport Act**” means the National Land Transport Act, 2009 (Act No. 5 of 2009);

“**National Road Traffic Act**” means the National Road Traffic Act, 1996 (Act No. 93 of 1996), and

“**the Act**” means the South African National Roads Agency Limited and National Roads Act, 1998 (Act No. 7 of 1998).

Information required and procedures applicable in respect of exempt public transport vehicles

2. (1) Any person who registers a motor vehicle as an exempt public transport vehicle must provide the Agency–

- (a) with the information contemplated in the attached Annexure A and in the manner required by the Agency, by completing such Annexure A and submitting the completed Annexure A to an e-toll customer service centre together with the documents required in sub-regulation (4); and
- (b) with an undertaking to comply with–
 - (i) the conditions of registration insofar as they apply to exempt public transport vehicles; and
 - (ii) the e-Road Regulations.

(2) The user of an exempt public transport vehicle on an e-road and who uses the exempt public transport vehicle for purposes or in circumstances other than for which the exemption was granted, shall be liable to pay e-toll for the appropriate category of user as if the exemption had not been granted.

(3) With regard to registration and the completion of Annexure A–

- (a) A certified copy of the current motor vehicle licence certificate for each motor vehicle must be submitted with Annexure A;

- (b) in the case of an articulated motor vehicle, a certified copy of the operating licence or permit or other particulars for both the truck-tractor and semi-trailer must be supplied to the Agency; and
 - (c) travel to a depot or base where the exempt public transport vehicle is kept when not in use, which are called positioning trips, must also be indicated on the map that is attached as a schedule to Annexure A.
- (4) The following documents must accompany Annexure A for registration of an exempt public transport vehicle:
- (a) A certified copy of the operating licence or permit issued for the motor vehicle in question in terms of the National Land Transport Act or recognized by that Act, or in the case of a contracted service as defined in the National Land Transport Act, a certified copy of the contract, as defined in that Act, if applicable;
 - (b) a certified copy of the current motor vehicle licence certificate for each motor vehicle; and
 - (c) the schedule to the attached Annexure A indicating the routes to be used by the exempt public transport vehicle.
- (5) When using an e-road on which an exempt public transport vehicle has been granted an exemption, the person driving or using the exempt public transport vehicle must at all times be in possession of the necessary operating licence or permit as required by section 50(1) of the National Land Transport Act, the original of which or a duplicate original must be available for inspection in the vehicle in terms of regulation 23(b) of the National Land Transport Regulations, 2009 promulgated in terms of the National Land Transport Act.

Information required and procedures applicable in respect of exempt ambulances, exempt traffic officer vehicles, exempt fire fighting vehicles, exempt rescue vehicles and exempt emergency medical response vehicles

3. (1) Any person who registers a vehicle as an exempt ambulance, exempt traffic officer vehicle, exempt fire fighting vehicle, exempt rescue vehicle or exempt emergency medical response vehicle must provide the Agency–

- (a) with the information contemplated in the attached Annexure A in addition to the documents contemplated in sub-regulation (2) in respect of each vehicle, by completing such Annexure A and submitting the completed Annexure A to

the Agency, together with the vehicle identification number and the date of issue of the current licence certificate for each vehicle; and

- (b) with an undertaking to comply with the conditions of registration, insofar as they apply to such vehicles, and the e-Road Regulations.

(2) A certified copy of the current motor vehicle licence certificate for each such vehicle must be submitted with the application.

(3) The user of an exempt vehicle contemplated in sub-regulation (1) on an e-road and who uses that vehicle for purposes or in circumstances other than for which the exemption was granted, shall be liable to pay e-toll, for the appropriate category of user as if the exemption had not been granted.

Information required and procedures applicable in respect of exempt adapted vehicles

4. (1) Any person who registers a vehicle as an exempt adapted vehicle must provide the Agency with–

- (a) proof that the vehicle will be used by persons who qualify as persons with physical disabilities, being persons who have long term physical impairments which, in interaction with various barriers, may hinder their full and effective participation in society on an equal basis with others; and
- (b) a certificate from a medical practitioner registered with the Health Professions Council of South Africa, including an impairment questionnaire, certifying that the person qualifies under paragraph (a).

(2) A person who registers a vehicle under sub-regulation (1) must submit the adapted vehicle to the Agency or its agent for inspection at a time and place to be determined by the Agency and communicated to that person.

(3) A person who registers a vehicle as an exempt adapted vehicle must also provide the Agency with–

- (a) the information contemplated in the attached Annexure A in respect of each vehicle, by completing such Annexure A and submitting the completed Annexure A to the Agency; and

(b) an undertaking to comply with the conditions of registration, insofar as they apply to exempt adapted vehicles, and the e-Road Regulations.

(4) A certified copy of the current motor vehicle licence certificate for each exempt adapted vehicle must be submitted with the application.

(5) The user of an exempt adapted vehicle on an e-road and who uses that vehicle for purposes or in circumstances other than for which the exemption was granted, shall be liable to pay e-toll for the appropriate category of user as if the exemption had not been granted.

Information required and procedures applicable in respect of exempt NGO vehicles and exempt NPO vehicles

5. (1) A non-government organisation (NGO) or non-profit organisation (NPO) who registers a vehicle as an exempt NGO or exempt NPO vehicle, as the case may be, must provide the Agency with—

- (a) proof that the NGO or NPO has been approved by the South African Revenue Service as a public benefit organisation under section 30 of the Income Tax Act, 1962 (Act No 58 of 1962);
- (b) proof that the NGO or NPO was established for the purposes of health care, persons with disabilities, welfare or humanitarian purposes or education and development; and
- (c) a written undertaking that the vehicle will be used by the relevant NGO or NPO.

(2) A person who registers a vehicle as an exempt NGO vehicle or exempt NPO vehicle must also provide the Agency with—

- (a) the information contemplated in the attached Annexure A in respect of each vehicle, by completing such Annexure and submitting the completed Annexure to the Agency; and
- (b) an undertaking to comply with the conditions of registration, insofar as they apply to exempt NGO vehicles or exempt NPO vehicles, as the case may be, and the e-Road Regulations.

(3) A certified copy of the current motor vehicle licence certificate for each exempt NGO and NPO vehicle must be submitted with the application.

(4) The user of an exempt NGO vehicle or exempt NPO vehicle on an e-road and who uses that vehicle for purposes or in circumstances other than for which the exemption was granted, shall be liable to pay e-toll, for the appropriate category of user as if the exemption had not been granted.

Information required and procedures applicable in respect of rebate for persons conveying persons with disabilities

6. (1) The owner of a vehicle conveying persons with disabilities who qualifies for a rebate must submit a registration form for the rebate in the format shown in Annexure B, and if the rebate is approved that owner must submit a monthly claim form in the format shown in Annexure C and the rebate will appear as a discount on the user's next monthly statement.

(2) The form mentioned in sub-regulation (1) must include—

- (a) a statement confirming particulars of trips where the person or persons with disabilities were conveyed;
- (b) a statement that the vehicle was used to convey persons who qualify as persons with disabilities, being persons who have physical, mental, intellectual or sensory impairments which, in interaction with various barriers, may hinder their full and effective participation in society on an equal basis with others, or a medical condition such as autism, mental health, epilepsy loss of hearing, and which disability is permanent and impairs functional mobility; and
- (c) particulars of the the vehicle or vehicles as indicated on the form.

(3) The form mentioned in sub-regulation (1) must be accompanied by a certificate from a medical practitioner registered with the Health Professions Council of South Africa, including an impairment questionnaire, certifying that the person or persons qualify under sub-regulation (2)(b).

(4) The user of a vehicle subject to a rebate on an e-road and who uses that vehicle for purposes or in circumstances other than for which the rebate was granted, shall be liable to pay e-toll, for the appropriate category of user as if the rebate had not been granted.

Procedures applicable to all exemptions

7. (1) Where exemption has been granted by the Agency, as applicable, from the payment of toll on a particular e-road–

- (a) the person who registers a vehicle with the Agency will be issued with an e-tag by the Agency for each vehicle, which e-tag will constitute a means of identifying the vehicle in respect of which the exemption has been granted; and
- (b) a document identifying the person who registered with the Agency will be issued by the Agency, if so decided by the Agency, which document is not transferable and which must be kept in the vehicle or on the person of the user when using an e-road for which exemption or rebate has been granted.

(2) The e-tag issued by the Agency for each such vehicle–

- (a) must, once issued, be affixed to each vehicle which has registered with the Agency in the manner specified in the Specification Regulations issued by the Minister in terms of section 58(1)(dB) of the Act; and
- (b) must, in order for the vehicle to be exempt from the payment of toll, be affixed to the relevant vehicle or vehicles of the user, as applicable, when using an e-road: Provided that this requirement shall however not apply to exempt public transport vehicles, prior to expiry of the transition period mentioned in the relevant notice published in the Government Gazette to provide for the exemption.

(3) The person who registers the vehicle with the Agency and for which exemption has been granted by the Agency must–

- (a) within 14 days of changing his or her physical or postal address or any of the particulars supplied to the Agency at the time of registration, notify the Agency of his, her or its new address or such new particulars;
- (b) notify the Agency within 24 hours after he, she or it becomes aware of the theft of the motor vehicle;
- (c) furnish information regarding the motor vehicle which is or may have been at any time in his, her or its possession to any authorised officer as defined in the National Land Transport Act, if requested to do so;

- (d) notify the Agency of any declaration that the motor vehicle has been declared unfit for use within 24 hours after the motor vehicle has so been declared unfit;
- (e) notify the Agency within 24 hours of the e-tag becoming damaged or stolen or destroyed and re-apply for a new e-tag in terms of the e-Road Regulations; and
- (f) ensure that the number plates of the motor vehicle that he, she or it is operating are affixed in the manner prescribed in regulation 35 of the National Road Traffic Regulations, 2000 made in terms of the National Road Traffic Act, and are clearly visible at all times.

(4) Registration will, subject to sub-regulation (9), be valid for three years from the date of registration of the vehicle and the person who registers the vehicle as an exempt vehicle, must apply to the Agency for renewal of the registration not less than 30 days prior to the registration having lapsed by completing the attached Annexure A and supplying the required particulars and documents to the Agency.

(5) If the vehicle that is exempt and is registered with the Agency, in terms hereof, is stolen, scrapped, sold or otherwise disposed of, or declared permanently unfit for use, the person who applied for registration of the vehicle must notify the Agency and supply the VLN or by telephoning an e-toll customer service centre, as contemplated in the e-Road Regulations, immediately on becoming aware that it was stolen, scrapped, sold or otherwise disposed of, or declared permanently unfit for use.

(6) The person who applied for registration of the vehicle in respect of which exemption was granted must notify the Agency within 24 hours if a vehicle registered with the Agency changes ownership or if an application is made to transfer the relevant operating licence or permit, or if the operating licence or permit lapses or is cancelled.

(7) If the person who applied for registration of the vehicle in respect of which exemption was granted elects to replace a vehicle with another vehicle and the new vehicle would still qualify for the exemption, then the person who applied for registration of the vehicle must apply for an e-tag for the new vehicle by completing the attached Annexure A and providing a certified copy of the motor vehicle licence certificate and other information required by the Agency, and the registration will not apply in respect of the new vehicle until the new e-tag issued by the Agency is affixed to the new vehicle in the manner prescribed in the Specification Regulations and, in the case of an exempt public transport vehicle, until the required operating licence for the new vehicle has been obtained.

(8) Exemption shall not apply where there has not been compliance with the requirements of sub-regulations (5), (6) and (7) and the user of the vehicle shall be liable to pay toll for the appropriate category of user as if the exemption had not been granted.

(9) Exemption from the payment of toll will lapse where—

- (a) the e-tag is used for any purpose other than in connection with the exemption granted to the vehicle;
- (b) the vehicle which is exempt from the payment of toll enters an e-road without the e-tag properly affixed to the vehicle: Provided that this requirement shall however not apply to exempt public transport vehicles, prior to expiry of the transition period mentioned in the relevant notice published in the Government Gazette to provide for the exemption;
- (c) the person using or driving the vehicle fails to comply with these regulations or the e-Road Regulations;
- (d) the operating licence or permit, if applicable, on which exemption was granted lapses or is withdrawn or cancelled for any reason;
- (e) the vehicle for which the exemption is granted is at any time not properly licensed or a valid roadworthy certificate has not been acquired for the vehicle as required by the National Road Traffic Act; or
- (f) the person using or driving the vehicle tampers with or defaces a number plate on such vehicle in contravention of the National Road Traffic Act.

(10) Where a person is required by any provision contained in these regulations to give notice to the Agency of any occurrence or for purposes of complying with any provision of these regulations, then such notice must be given either by contacting the call centre or by visiting an e-toll customer service centre, or by any other means of notification that is given on the website as defined in the e-Road Regulations.

Requirements for owner of vehicle for which a rebate is claimed

8. In order to claim the rebate contemplated in regulation 6 for a vehicle the owner of the vehicle must—

- (a) be a registered user as defined in the e-Road Regulations;
- (b) have acquired an e-tag for and fitted it to the vehicle, and

(c) have complied fully with the e-Road Regulations.

Repeal of regulations

9. The Regulations on Exemptions from the Payment of Tolls, 2013 published under notice R.741 of 9 October 2013 are hereby repealed.

Short title and commencement

10. These Regulations are called the Regulations on Exemptions from and Rebates on the Payment of Tolls, 2016 and shall come into operation on the date of publication in the *Government Gazette*.

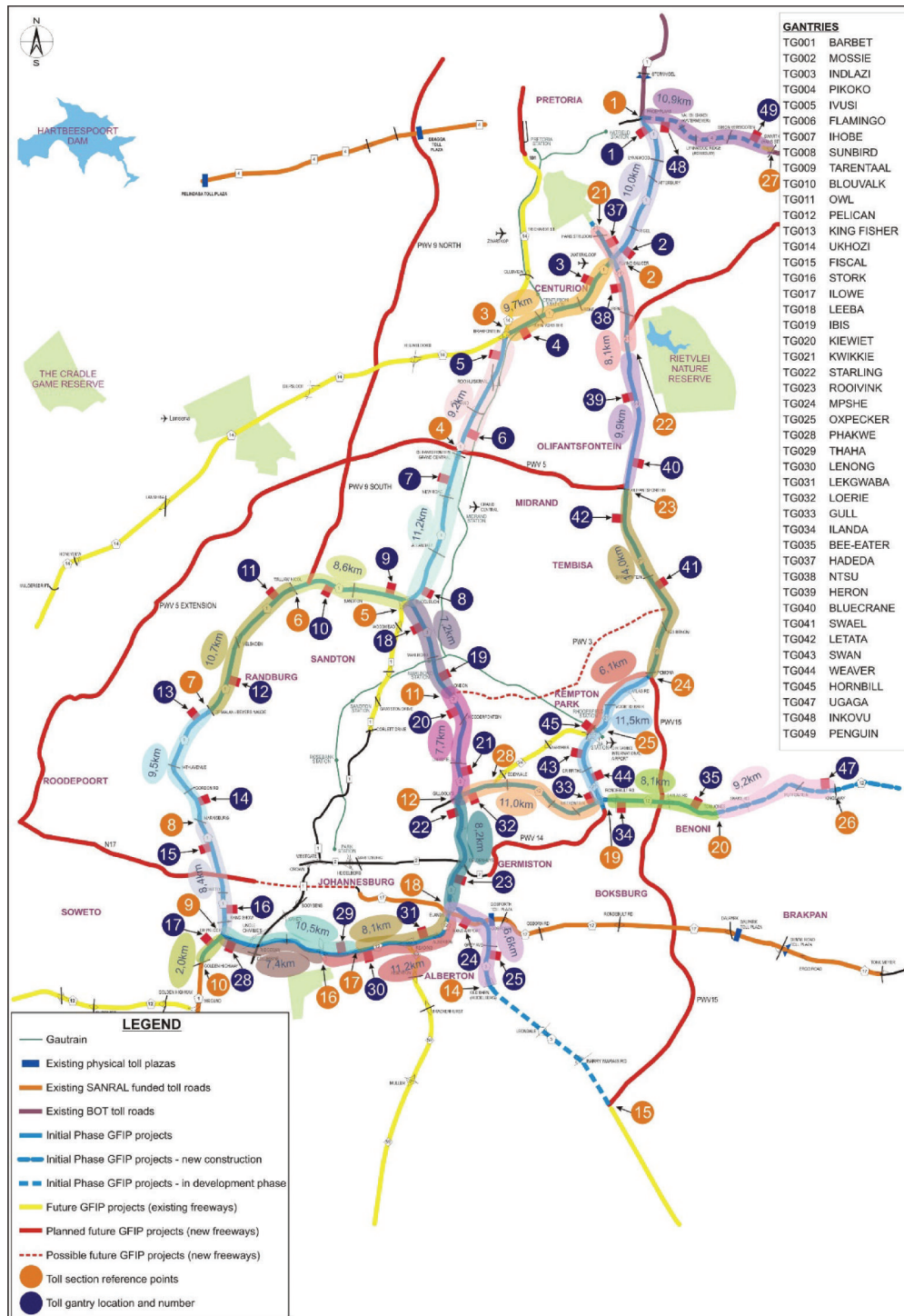

1. In hierdie Regulasies, tensy uit die samehang anders blyk, het 'n woord of uitdrukking wat in die Wet, die Wet op Nasionale Landvervoer en die e-Pad Regulasies omskryf word, dieselfde betekenis, en beteken –

“die Wet” die Wet op die Suid-Afrikaanse Nasionale Padagentskap Beperk en op Nasionale Paaie, 1998 (Wet Nr. 7 van 1998);

“e-Pad Regulasies” die e-Pad Regulasies, 2013 wat die Minister kragtens artikel 58(1)(dA) en (dC) van die Wet gemaak het;

“GDVP e-tolpaaie” die paaie wat vir die Gauteng Deurpad Verbeteringsprojek verklaar is soos gespesifiseer in die betrokke vrystellings en kortings wat deur die Minister of die Agentskap met betrekking tot daardie Projek gepubliseer het;

“Nasionale Landvervoerwet” die Nasionale Landvervoerwet, 2009 (Wet Nr. 5 van 2009);

“Nasionale Padverkeerswet” die Nasionale Padverkeerswet, 1996 (Wet Nr. 93 van 1996);

“vrygestelde aangepaste voertuig” ‘n motorvoertuig wat spesiaal vir gebruik deur, of om bestuur te word deur, persone met ongeskikthede, aangepas is;

“vrygestelde ambulans” ‘n ambulans wat as sulks kragtens die Nasionale Padverkeerswet geregistreer is en wat as ‘n ambulans gemerk is en wat deur die Agentskap kragtens artikel 27(1)(c) van die Wet van die aanspreeklikheid om e-tol op ‘n e-pad of enige deel van ‘n e-pad te betaal, vrygestel is;

“vrygestelde brandbestrydingsvoertuig” ‘n brandbestrydingsvoertuig wat as sulks kragtens die Nasionale Padverkeerswet geregistreer is en wat as ‘n brandbestrydingsvoertuig gemerk is en wat deur die Agentskap kragtens artikel 27(1)(c) van die Wet van die aanspreeklikheid om e-tol op ‘n e-pad of enige deel van ‘n e-pad te betaal, vrygestel is;

“vrygestelde nood-mediese reaksievoertuig” ‘n vrygestelde nood-mediese reaksievoertuig wat slegs vir mediese reaksiedoeleindes gebruik word en as sulks kragtens die Nasionale Padverkeerswet, 1996 (Wet Nr. 93 van 1996) geregistreer is en wat deur die Agentskap kragtens artikel 27(1)(c) van die Wet van die aanspreeklikheid om e-tol op ‘n e-pad of enige deel van ‘n e-pad te betaal, vrygestel is;

“vrygestelde NSO-voertuig” ‘n motorvoertuig wat deur ‘n kwalifiserende nie-staatsorganisasie (NSO) gebruik word om persone met ongeskikthede te vervoer of vir doeleindes van gesondheidsorg, weldaad of medemenslikheid, of onderwys en ontwikkeling en wat deur die Agentskap kragtens artikel 27(1)(c) van die Wet van die aanspreeklikheid om e-tol op ‘n e-pad of enige gedeelte van ‘n e-pad te betaal, vrygestel is;

“vrygestelde openbare vervoervoertuig” ‘n voertuig wat ‘n openbare vervoerdiens verskaf en wat deur die Agentskap kragtens artikel 27(1)(c) van die Wet van die aanspreeklikheid om e-tol op ‘n e-pad of enige gedeelte van ‘n e-pad te betaal, vrygestel is; en

“vrygestelde OSW-voertuig” ‘n motorvoertuig wat deur ‘n kwalifiserende organisasie sonder winsoogmerk (OSW) gebruik word om persone met ongeskikthede te vervoer of vir doeleindes van gesondheidsorg, weldaad of medemenslikheid, of onderwys en ontwikkeling

en wat deur die Agentskap kragtens artikel 27(1)(c) van die Wet van die aanspreeklikheid om e-tol op 'n e-pad of enige gedeelte van 'n e-pad te betaal, vrygestel is;

“vrygestelde reddingsvoertuig” 'n reddingsvoertuig wat slegs vir doeleindes van die redding van persone gebruik word wat as 'n reddingsvoertuig kragtens die Nasionale Padverkeerswet geregistreer is en deur die Agentskap kragtens artikel 27(1)(c) van die Wet van die aanspreeklikheid om e-tol op 'n e-pad of enige gedeelte van 'n e-pad te betaal, vrygestel is, en

“vrygestelde verkeersbeampte-voertuig” 'n voertuig wat deur 'n verkeersbeampte soos omskryf in artikel 1 van die Nasionale Padverkeerswet gebruik word en as 'n verkeersbeampte-voertuig gemerk is en deur die Agentskap kragtens artikel 27(1)(c) van die Wet van die aanspreeklikheid om e-tol op 'n e-pad of enige gedeelte van 'n e-pad te betaal, vrygestel is.

Inligting wat benodig word en prosedures wat met betrekking tot vrygestelde openbare vervoervoertuie van toepassing is

2. (1) Iemand wat 'n motorvoertuig as 'n vrygestelde openbare vervoervoertuig registreer moet die Agentskap voorsien van–

- (a) die inligting beoog in die aangehegte Aanhangel A en op die wyse voorgeskryf deur die Agentskap, deur sodanige Aanhangel te voltooi en die voltooide Aanhangel by 'n e-tol kliëntedienssentrum tesame met die dokumente in sub-regulasie (4) vereis, in te dien; en
- (b) 'n onderneming om te voldoen aan–
 - (i) die registrasievoorwaardes insoverre dit op vrygestelde openbare vervoervoertuie van toepassing is; en
 - (ii) die e-Pad Regulasies.

(2) Die gebruiker van 'n vrygestelde openbare vervoervoertuig op 'n e-pad wat die vrygestelde openbare vervoervoertuig gebruik vir doeleindes of in omstandighede anders as dié waarvoor die vrystelling toegestaan is, is aanspreeklik om e-tol vir die toepaslike kategorie van gebruiker te betaal asof die vrystelling nooit toegestaan is nie.

- (3) Met betrekking tot registrasie en die voltooiing van die Aanhangel moet–

- (a) 'n Gesertifiseerde afskrif van die huidige motorvoertuig-lisensiesertifikaat vir elke motorvoertuig tesame met die Aanhangsel ingedien word;
 - (b) in die geval van 'n gelede motorvoertuig, 'n gesertifiseerde afskrif van die bedryfslisensie of permit of ander besonderhede vir beide die voorspanmotor en die leunwa aan die Agentskap verskaf word; en
 - (c) vervoer na 'n depot of opslagplek waar die vrygestelde openbare vervoervoertuig gehou word wanneer dit nie gebruik word nie (wat positioneringsritte genoem word) ook op die kaart wat as 'n aanhangsel by die Aanhangsel aangeheg is, aangedui word.
- (4) Die volgende dokumente moet die Aanhangsel vir registrasie van 'n vrygestelde openbare vervoervoertuig vergesel:
- (a) 'n Gesertifiseerde afskrif van die bedryfslisensie of permit wat vir die betrokke voertuig in terme van die Nasionale Landvervoerwet uitgereik is, of wat deur daardie Wet erken word, of in die geval van 'n gekontrakteerde diens soos in die Nasionale Landvervoerwet omskryf, 'n gesertifiseerde afskrif van die kontrak, soos in daardie Wet omskryf, indien van toepassing;
 - (b) 'n gesertifiseerde afskrif van die huidige motorvoertuig-lisensiesertifikaat vir elke voertuig; en
 - (c) die aanhangsel by die aangehegde Aanhangsel A wat die roetes aantoon wat deur die vrygestelde openbare vervoervoertuie gebruik sal word.
- (5) Wanneer 'n e-pad gebruik word waarop 'n vrystelling aan 'n vrygestelde openbare vervoervoertuig toegestaan is, moet die persoon wat die vrygestelde openbare vervoervoertuig bestuur of gebruik te alle tye in besit wees van die nodige bedryfslisensie of permit soos deur artikel 50(1) van die Nasionale Landvervoerwet vereis word, waarvan die oorspronklike of 'n duplikaatoorspronklike in die voertuig vir inspeksie beskikbaar moet wees uit hoofde van regulasie 23(b) van die Nasionale Landvervoerregulasies, 2009 wat kragtens die Nasionale Landvervoerwet gepromulgeer is.

Inligting benodig en prosedures van toepassing met betrekking tot vrygestelde ambulanse, vrygestelde verkeersbeampte-voertuie, vrygestelde brandbestrydingsvoertuie, vrygestelde reddingsvoertuie en vrygestelde nood-mediese reaksievoertuie

3. (1) Iemand wat 'n voertuig as 'n vrygestelde ambulans, vrygestelde verkeersbeampte-voertuig, vrygestelde brandbestrydingsvoertuig, vrygestelde

reddingsvoertuig of vrygestelde nood-mediese reaksievoertuig registreer moet die Agentskap voorsien van-

- (a) die inligting in die aangehegde Aanhangel A beoog asook die dokumente beoog in sub-regulasie (2) met betrekking tot elke voertuig, deur sodanige Aanhangel te voltooi en die voltooide Aanhangel by die Agentskap in te dien, tesame met die voertuigidentifikasienommer en die datum van uitreiking van die huidige lisensiesertifikaat vir elke voertuig; en
 - (b) met 'n onderneming om te voldoen aan die registrasievoorwaardes van sodanige voertuie, en die e-Pad Regulasies.
- (2) 'n Gesertifiseerde afskrif van die huidige motorvoertuig-lisensiesertifikaat vir elke sodanige voertuig moet by die aansoek ingedien word.
- (3) Die gebruiker van 'n vrygestelde voertuig beoog in sub-regulasie (1) op 'n e-pad en wat die voertuig vir doeleindes of in omstandighede anders as waarvoor die vrystelling toegestaan is, gebruik, is aanspreeklik om e-tol vir die toepaslike kategorie van gebruiker te betaal asof die vrystelling nooit toegestaan is nie.

Inligting benodig en prosedures van toepassing met betrekking tot vrygestelde aangepaste voertuie

4. (1) Iemand wat 'n voertuig as 'n vrygestelde aangepaste voertuig registreer moet die Agentskap voorsien van-

- (a) bewys dat die voertuig deur 'n persoon of persone wat kwalifiseer as 'n persoon met fisiese ongeskikthede gebruik sal word, synde persone wat langtermyn fisiese gebreke het wat, in samewerking met ander stremmings, hulle volle en doetreffende deelname in die samelewing op 'n gelyke basis met ander persone kan strem; en
 - (b) 'n sertifikaat van 'n mediese praktisyn geregistreer by die Gesondheidpraktisynsraad van Suid-Afrika, tesame met 'n ongeskiktheidsvraestel wat sertifiseer dat die persoon onder paragraaf (a) kwalifiseer.
- (2) Iemand wat 'n voertuig kragtens sub-regulasie (1) registreer moet die aangepaste voertuig aan die Agentskap of sy agent voorlê vir inspeksie op 'n tyd en by 'n plek wat die Agentskap vasstel en aan daardie persoon bekend gemaak is.

(3) Iemand wat 'n voertuig as 'n vrygestelde aangepaste voertuig registreer moet die Agentskap voorsien van–

- (a) die inligting beoog in die aangehegde Aanhangsel A met betrekking tot elke voertuig, deur sodanige Aanhangsel te voltooi en dit aan die Agentskap te voorsien; en
- (b) 'n onderneming om aan die voorwaardes van registrasie, insoverre dit op aangepaste vrygestelde voertuie van toepassing is, en die e-Pad Regulasies, te voldoen.

(4) 'n Gesertifiseerde afskrif van die huidige motorvoertuig-lisensiesertifikaat vir elke aangepaste voertuig moet saam met die aansoek ingedien word.

(5) Die gebruiker van 'n vrygestelde aangepaste voertuig op 'n e-pad wat die voertuig vir doeleindes of in omstandighede anders as waarvoor die vrystelling toegestaan is, gebruik, is aanspreeklik om e-tol vir die toepaslike kategorie van gebruiker te betaal asof die vrystelling nooit toegestaan is nie.

Inligting benodig en prosedures van toepassing met betrekking tot vrygestelde NSO-voertuie en vrygestelde OSW-voertuie

5. (1) 'n Nie-staats organisasie (NSO) of organisasie sonder winsoogmerk (OSW) wat 'n voertuig as 'n vrygestelde NSO-voertuig of OSW-voertuig, soos die geval mag wees, registreer, moet die Agentskap voorsien van–

- (a) bewys dat die NSO of OSW deur die Suid-Afrikaanse Inkomstediens as 'n openbare welsynsinstelling kragtens artikel 30 van die Wet op Inkomstebelasting, 1962 (Wet Nr. 58 van 1962) goeagekeur is;
- (b) bewys dat die NSO of OSW vir doeleindes van gesondheidsorg, persone met ongeskikthede, welsyns- of medemenslikheidsdoeleindes gestig is, of onderwys en ontwikkeling; en
- (c) 'n geskrewe onderneming dat die voertuig deur die betrokke NSO of OSW gebruik sal word.

(2) Iemand wat 'n voertuig as 'n vrygestelde NSO-voertuig of vrygestelde OSW-voertuig registreer moet die Agentskap ook voorsien van–

- (a) die inligting beoog in die aangehegte Aanhangsel A, deur sodanige Aanhangsel te voltooi en die voltooide Aanhangsel by die Agentskap in te dien; en
 - (b) 'n onderneming om aan die voorwaardes van registrasie, insoverre dit op vrygestelde NSO-voertuie of vrygestelde OSW-voertuie, soos die geval mag wees, van toepassing is, en die e-Pad Regulasies, te voldoen.
- (3) 'n Gesertifiseerde afskrif van die huidige motorvoertuig-lisensiesertifikaat vir elke vrygestelde NSO-voertuig en vrygestelde OSW-voertuig moet saam met die aansoek ingedien word.
- (4) Die gebruiker van 'n vrygestelde NSO-voertuig of vrygestelde OSW-voertuig op 'n e-pad wat die voertuig vir doeleindes of in omstandighede anders as waarvoor die vrystelling toegestaan is, gebruik, is aanspreeklik om e-tol vir die toepaslike kategorie van gebruiker te betaal asof die vrystelling nooit toegestaan is nie.

Inligting benodig en prosedures van toepassing met betrekking tot korting vir persone wat persone met ongeskikthede vervoer

6. (1) Die eienaar van 'n voertuig wat persone met ongeskikthede vervoer en wat vir 'n korting kwalifiseer moet 'n registrasievorm vir die korting indien in die formaat getoon in Aanhangsel B, en as die korting goedgekeur word moet sodanige eienaar 'n maandelikse eisvorm indien in die format getoon in Aanhangsel C, en sal die korting as 'n afslag op die gebruiker se volgende maandelikse staat verskyn.
- (2) Die vorm gemeld in sub-regulasie (1) moet insluit–
 - (a) 'n verklaring wat besonderhede van die ritte waar die persoon of persone met ongeskikthede vervoer is, bevestig;
 - (b) 'n verklaring dat die voertuig gebruik is om persone wat kwalifiseer as persone met ongeskikthede te vervoer, synde persone wat fisiese, geestelike, intellektuele of sintuiglike gebreke het wat, in samewerking met ander stremings, hulle volle en doetreffende deelname in die samelewing op 'n gelyke basis met ander persone kan strem, of 'n mediese toestand soos outisme, geestelike gesondheid, epilepsie of hardhorendheid en welke ongeskiktheid permanent is en funksionele mobiliteit kan strem; en
 - (c) besonderhede van die voertuig of voertuie soos op die vorm aangedui.
 - (3) Die vorm in sub-regulasie (1) vermeld moet saamgaan met 'n sertifikaat van 'n mediese praktisyn geregistreer by die Gesondheidpraktisynsraad van Suid Afrika, tesame

met 'n ongeskiktheidsvraestel, wat sertifiseer dat die persoon onder sub-regulasie (2)(b) kwalifiseer.

(4) Die gebruiker van 'n voertuig waarop 'n korting betrekking het op 'n e-pad wat die voertuig vir doeleindes of in omstandighede anders as waarvoor die korting toegestaan is, gebruik, is aanspreeklik om e-tol vir die toepaslike kategorie van gebruiker te betaal asof die korting nooit toegestaan is nie.

Prosedures van toepassing by alle vrystellings

7. (1) Waar vrystelling deur die Agentskap van die betaling van e-tol op 'n bepaalde e-pad toegestaan is—

- (a) sal die persoon wat kies om 'n voertuig by die Agentskap te registreer, met 'n e-tag deur die Agentskap voorsien word vir elke voertuig, welke e-tag die metode sal wees om die voertuig waarvoor vrystelling verleen is, te identifiseer; en
- (b) sal 'n dokument wat die persoon wat by die Agentskap geregistreer is, identifiseer, deur die Agenstkap uitgereik word, indien die Agentskap aldus besluit, welke dokument nie oordraagbaar is nie and wat in die voertuig of by die persoon of gebruiker gehou moet word wanneer 'n e-pad waarvoor vrystelling toegestaan is, gebruik word.

(2) Die e-tag wat deur die Agentskap vir elke vrygestelde voertuig uitgereik is—

- (a) moet by uitreiking daarvan by elke voertuig wat by die Agentskap geregistreer is, aangebring word op die wyse voorgeskryf in die Spesifikasie Regulasies wat deur die Minister ingevolge artikel 58(1)(dB) van die Wet uitgereik is; en
- (b) moet, sodat die voertuig van die betaling van tol vrygestel kan wees, by die betrokke voertuig of voertuie van die gebruiker, soos van toepassing, aangebring word wanneer 'n e-pad gebruik word: Met dien verstande dat sodanige vereiste egter nie van toepassing is op vrygestelde openbare vervoervoertuie nie, voor verstryking van die oorgangstydperk wat in die betrokke kennisgewing gemeld is wat in die Staatskoerant gepubliseer is om voorsiening te maak vir die vrystelling.

(3) Die persoon wat die voertuig by die Agentskap registreer en waarvoor vrystelling deur die Agentskap toegestaan is, moet—

- (a) binne 14 dae nadat sy of haar fisiese- of posadres, of enige van die besonderhede wat tydens registrasie aan die Agentskap verskaf is, verander is, die Agentskap van sy of haar nuwe adres of sodanige nuwe besonderhede in kennis stel;
- (b) die Agentskap binne 24 uur in kennis stel nadat dit tot sy of haar kennis gekom het dat die motorvoertuig gesteel is;
- (c) inligting aangaande die vrygestelde voertuig wat te enige tyd in sy of haar besit was, aan enige bevoegde beampte soos in the Nasionale Landvervoerwet omskryf, verskaf, indien aldus versoek;
- (d) die Agentskap in kennis stel van enige verklaring dat die motorvoertuig ongeskik is vir diens binne 24 uur nadat die motorvoertuig aldus ongeskik verklaar is;
- (e) die Agentskap binne 24 uur in kennis stel indien die e-tag beskadig of gesteel is en weer vir 'n nuwe e-tag ingevolge die e-Pad Regulasies aansoek doen; en
- (f) verseker dat die nommerplate van die motorvoertuig wat hy of sy bedryf op die wyse voorgeskryf in regulasie 35 van die Nasionale Padverkeerregulasies, 2000, welke regulasies kragtens die Nasionale Padverkeerwet gemaak is, aangebring is, en dat dit te alle tye duidelik sigbaar is.

(4) Registrasie sal, behoudens sub-regulasie (9), vir drie jaar vanaf die datum van registrasie van die vrygestelde voertuig, geldig wees, waarna die registrasie verval en die persoon wat kies om die voertuig as 'n vrygestelde voertuig te registreer, by die Agentskap aansoek moet doen om hernuwing van die registrasie nie minder as 30 dae voor die registrasie sal verval, deur die aangehegte Aanhangel A te voltooi en die benodigde besonderhede en dokumente aan die Agentskap te verskaf.

(5) Indien die voertuig wat vrygestel is en by die Agentskap in terme hiervan geregistreer is, gesteel, gesloop, verkoop of andersins vervreem word, of permanent vir diens ongeskik verklaar is, moet die persoon wat om registrasie aansoek gedoen het die Agentskap in kennis stel en die VLN verskaf of 'n e-tol kliëntedienssentrum telefoneer, soos beoog in die e-Pad Regulasies, onmiddellik nadat dit tot sy of haar kennis gekom het dat dit gesteel, gesloop, verkoop of andersins vervreem is, of permanent vir diens ongeskik verklaar is.

(6) Die persoon wat aansoek gedoen het om registrasie van die voertuig met betrekking waartoe vrystelling verleen is, moet die Agentskap binne 24 uur in kennis stel indien 'n voertuig wat by die Agentskap geregistreer is van eienaarskap verander of indien aansoek gedoen word om die betrokke bydryfslisensie of permit oor te dra, of indien die bedryfslisensie of permit verval of gekanselleer word.

(7) Indien die persoon wat aansoek gedoen het om registrasie van die voertuig waarvoor vrystelling verleen is, kies om die voertuig met 'n ander voertuig te vervang en die nuwe voertuig ook nog kwalifiseer vir die vrystelling wat deur die Agentskap verleen is, moet die persoon wat aansoek gedoen het om registrasie van die voertuig aansoek doen om 'n e-tag vir die nuwe voertuig deur die aangehegde Aanhangel A te voltooi en 'n gesertifiseerde afskrif van die voertuiglisensiesertifikaat te verskaf, asook ander inligting wat die Agentskap benodig, en die registrasie sal nie op die nuwe voertuig van toepassing wees nie totdat die nuwe e-tag wat die Agentskap verskaf by die nuwe voertuig aangebring is op die wyse voorgeskryf in die Spesifikasie Regulasies en, in die geval van 'n vrygestelde openbare vervoervoertuig, totdat die nodige bedryfslisensie vir die nuwe voertuig verkry is.

(8) Die vrystelling sal nie van toepassing wees nie waar die vereistes van sub-regulasies (5), (6) en (7) nie nagekom is nie, en die gebruiker van die voertuig sal dan aanspreeklik wees om e-tol te betaal asof die vrystelling nooit toegestaan is nie.

(9) Vrystelling van die aanspreeklikheid om tol te betaal verval as-

- (a) die e-tag vir 'n doel anders as met betrekking tot die doel waarvoor die vrystelling aan die vrygestelde voertuig verleen is, gebruik word;
- (b) die voertuig wat vrygestel is van die betaling van e-tol 'n e-pad betree sonder dat die e-tag behoorlik by die voertuig aangebring is: Met dien verstande dat sodanige vereiste egter nie van toepassing is op vrygestelde openbare vervoervoertuie nie, voor verstryking van die oorgangstydperk wat in die betrokke kennisgewing gemeld is wat in die Staatskoerant gepubliseer is om voorsiening te maak vir die vrystelling;
- (c) die persoon wat die voertuig gebruik of bestuur versuim om aan hierdie Regulasies of die e-Pad Regulasies te voldoen;
- (d) die bedryfslisensie of permit, indien van toepassing, waarkragtens vrystelling verleen is, verval of om enige rede ingetrek of gekanselleer is;

- (e) die voertuig waarvoor die vrystelling verleen is te eniger tyd nie behoorlik gellisenseer is nie of 'n geldige padwaardigheidsertifikaat nie vir die voertuig verkry is nie soos deur die Nasionale Padverkeerswet vereis; of
- (f) die persoon wat die voertuig gebruik of bestuur met 'n nommerplaat op sodanige voertuig peuter of dit skend, teenstrydig met die Nasionale Padverkeerswet.

(10) Waar iemand deur enige bepaling van hierdie regulasies vervat verplig is om die Agentskap kennis te gee van enige gebeurlikheid of vir die doel om aan enige bepaling van hierdie regulasies te voldoen, moet sodanige kennis gegee word deur of die inbelsentrum te kontak of deur die e-tol kliëntedienssentrum te besoek, of op enige ander wyse van kennisgewing wat op die webwerf, soos in die e-Pad Regulasies omskryf, aangedui word.

Vereistes vir eienaar van voertuig waarvoor 'n korting geëis word

8. Om die korting beoog in regulasie 6 te eis, moet die eienaar van die voertuig–
- (a) 'n geregistreerde gebruiker wees soos omskryf in die e-Pad Regulasies;

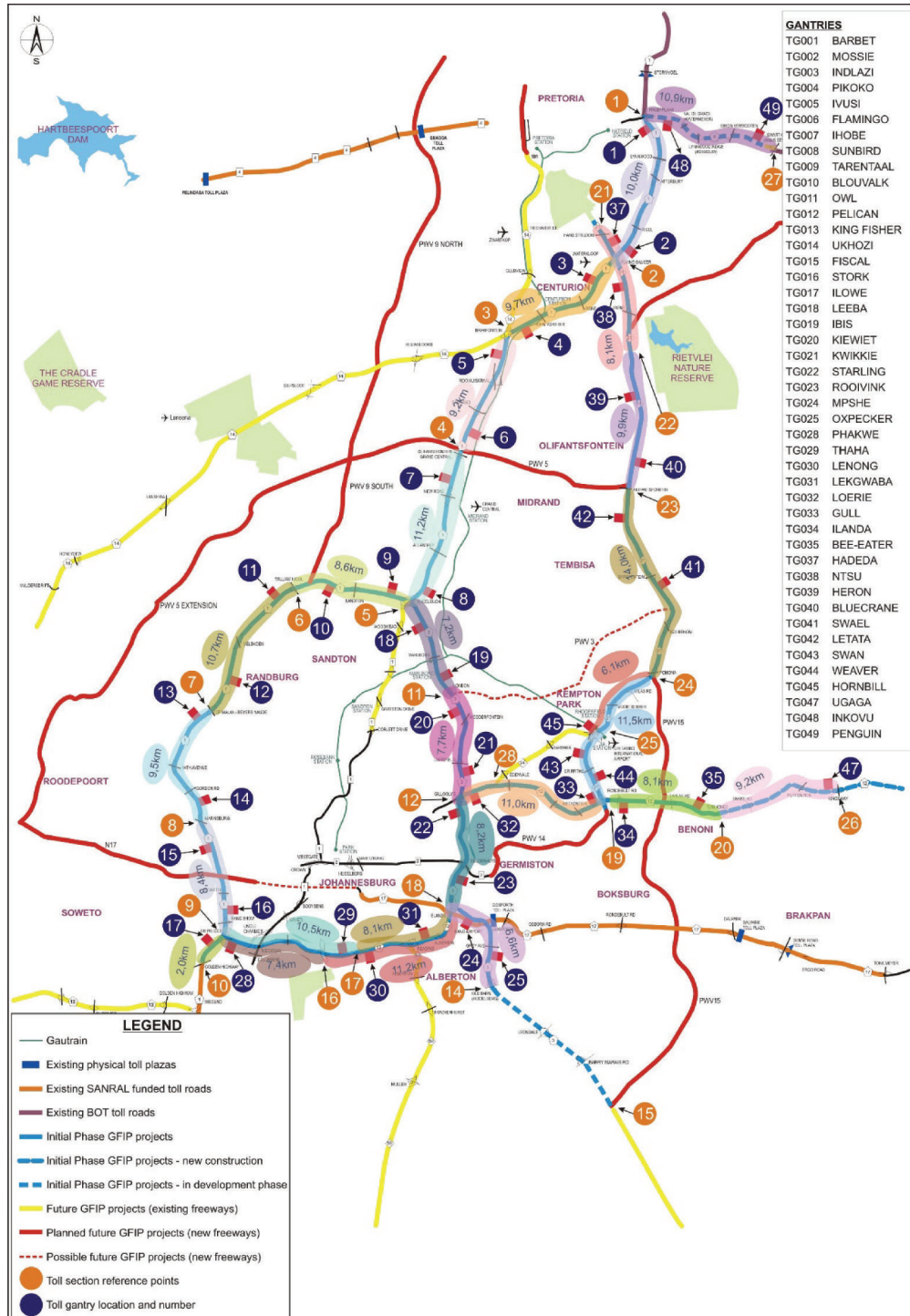

I, Elizabeth Dipuo Peters, the Minister of Transport hereby, in terms of section 58(1)(dA) and (dC) of The South African National Roads Agency Limited and National Roads Act, 1998 (Act No. 7 of 1998) and after consultation with the Agency, make the regulations in the Schedule hereto.

**MS DIPUO PETERS, MP****MINISTER OF TRANSPORT****SCHEDULE****Definitions**

1. In these Regulations, any word or expression to which a meaning has been assigned in the Act, the National Land Transport Act or the e-Road Regulations shall have the same meaning and, unless the context indicates otherwise—

“e-Road Regulations” means the e-Road Regulations, 2013 made by the Minister under section 58(1)(dA) and (dC) of the Act;

“exempt adapted vehicle” means a motor vehicle that is specially adapted for use by or to be driven by persons with disabilities;

“exempt ambulance” means an ambulance registered as such in terms of the National Road Traffic Act and marked as an ambulance and that has been exempted by the Agency, in terms of section 27(1)(c) of the Act, from the liability to pay e-toll on an e-road or any portion of an e-road;

“exempt emergency medical response vehicle” means an emergency medical response vehicle used only for medical response purposes that is registered as such in terms of the National Road Traffic Act and that has been exempted by the Agency, in terms of section 27(1)(c) of the Act, from the liability to pay e-toll on an e-road or any portion of an e-road;

“exempt fire-fighting vehicle” means a fire-fighting vehicle registered in terms of the National Road Traffic Act and marked as a fire-fighting vehicle and that has been exempted by the Agency, in terms of section 27(1)(c) of the Act, from the liability to pay e-toll on an e-road or any portion of an e-road;

“exempt NGO vehicle” means a motor vehicle owned or used by a qualifying non-government organisation (NGO) that is used for conveying persons with disabilities or for the purposes of health care, welfare or humanitarian purposes or education and development and that is exempted by the Agency, in terms of section 27(1)(c) of the Act, from the liability to pay e-toll on an e-road or any portion of an e-road;

“exempt NPO vehicle” means a motor vehicle owned or used by a qualifying non-profit organisation (NPO) that is used for conveying persons with disabilities or for the purposes of health care, welfare or humanitarian purposes or education and development and that is exempted by the Agency, in terms of section 27(1)(c) of the Act, from the liability to pay e-toll on an e-road or any portion of an e-road;

“exempt public transport vehicle” means a motor vehicle that provides a public transport service and that is exempted by the Agency, in terms of section 27(1)(c) of the Act, from the liability to pay e-toll on an e-road or any portion of an e-road;

“exempt rescue vehicle” means a rescue vehicle used only for the purpose of rescuing persons that is registered as a rescue vehicle in terms of the National Road Traffic Act and that has been exempted by the Agency, in terms of section 27(1)(c) of the Act, from the liability to pay e-toll on an e-road or any portion of an e-road;

“exempt traffic officer vehicle” means a vehicle used by a traffic officer as defined in section 1 of the National Road Traffic Act and marked as a traffic officer vehicle and that has been exempted by the Agency, in terms of section 27(1)(c) of the Act, from the liability to pay e-toll on an e-road or any portion of an e-road;

“GFIP toll-roads” means the roads declared for the Gauteng Freeway Improvement Project as specified in the relevant exemptions or rebates published by the Minister or the Agency in relation to that Project;

“National Land Transport Act” means the National Land Transport Act, 2009 (Act No. 5 of 2009);

“**National Road Traffic Act**” means the National Road Traffic Act, 1996 (Act No. 93 of 1996), and

“**the Act**” means the South African National Roads Agency Limited and National Roads Act, 1998 (Act No. 7 of 1998).

Information required and procedures applicable in respect of exempt public transport vehicles

2. (1) Any person who registers a motor vehicle as an exempt public transport vehicle must provide the Agency–

- (a) with the information contemplated in the attached Annexure A and in the manner required by the Agency, by completing such Annexure A and submitting the completed Annexure A to an e-toll customer service centre together with the documents required in sub-regulation (4); and
- (b) with an undertaking to comply with–
 - (i) the conditions of registration insofar as they apply to exempt public transport vehicles; and
 - (ii) the e-Road Regulations.

(2) The user of an exempt public transport vehicle on an e-road and who uses the exempt public transport vehicle for purposes or in circumstances other than for which the exemption was granted, shall be liable to pay e-toll for the appropriate category of user as if the exemption had not been granted.

(3) With regard to registration and the completion of Annexure A–

- (a) A certified copy of the current motor vehicle licence certificate for each motor vehicle must be submitted with Annexure A;
- (b) in the case of an articulated motor vehicle, a certified copy of the operating licence or permit or other particulars for both the truck-tractor and semi-trailer must be supplied to the Agency; and
- (c) travel to a depot or base where the exempt public transport vehicle is kept when not in use, which are called positioning trips, must also be indicated on the map that is attached as a schedule to Annexure A.

(4) The following documents must accompany Annexure A for registration of an exempt public transport vehicle:

- (a) A certified copy of the operating licence or permit issued for the motor vehicle in question in terms of the National Land Transport Act or recognized by that Act, or in the case of a contracted service as defined in the National Land Transport Act, a certified copy of the contract, as defined in that Act, if applicable;
- (b) a certified copy of the current motor vehicle licence certificate for each motor vehicle; and
- (c) the schedule to the attached Annexure A indicating the routes to be used by the exempt public transport vehicle.

(5) When using an e-road on which an exempt public transport vehicle has been granted an exemption, the person driving or using the exempt public transport vehicle must at all times be in possession of the necessary operating licence or permit as required by section 50(1) of the National Land Transport Act, the original of which or a duplicate original must be available for inspection in the vehicle in terms of regulation 23(b) of the National Land Transport Regulations, 2009 promulgated in terms of the National Land Transport Act.

Information required and procedures applicable in respect of exempt ambulances, exempt traffic officer vehicles, exempt fire fighting vehicles, exempt rescue vehicles and exempt emergency medical response vehicles

3. (1) Any person who registers a vehicle as an exempt ambulance, exempt traffic officer vehicle, exempt fire fighting vehicle, exempt rescue vehicle or exempt emergency medical response vehicle must provide the Agency–

- (a) with the information contemplated in the attached Annexure A in addition to the documents contemplated in sub-regulation (2) in respect of each vehicle, by completing such Annexure A and submitting the completed Annexure A to the Agency, together with the vehicle identification number and the date of issue of the current licence certificate for each vehicle; and
- (b) with an undertaking to comply with the conditions of registration, insofar as they apply to such vehicles, and the e-Road Regulations.

(2) A certified copy of the current motor vehicle licence certificate for each such vehicle must be submitted with the application.

(3) The user of an exempt vehicle contemplated in sub-regulation (1) on an e-road and who uses that vehicle for purposes or in circumstances other than for which the exemption was granted, shall be liable to pay e-toll, for the appropriate category of user as if the exemption had not been granted.

Information required and procedures applicable in respect of exempt adapted vehicles

4. (1) Any person who registers a vehicle as an exempt adapted vehicle must provide the Agency with—

- (a) proof that the vehicle will be used by persons who qualify as persons with physical disabilities, being persons who have long term physical impairments which, in interaction with various barriers, may hinder their full and effective participation in society on an equal basis with others; and
- (b) a certificate from a medical practitioner registered with the Health Professions Council of South Africa, including an impairment questionnaire, certifying that the person qualifies under paragraph (a).

(2) A person who registers a vehicle under sub-regulation (1) must submit the adapted vehicle to the Agency or its agent for inspection at a time and place to be determined by the Agency and communicated to that person.

(3) A person who registers a vehicle as an exempt adapted vehicle must also provide the Agency with—

- (a) the information contemplated in the attached Annexure A in respect of each vehicle, by completing such Annexure A and submitting the completed Annexure A to the Agency; and
- (b) an undertaking to comply with the conditions of registration, insofar as they apply to exempt adapted vehicles, and the e-Road Regulations.

(4) A certified copy of the current motor vehicle licence certificate for each exempt adapted vehicle must be submitted with the application.

(5) The user of an exempt adapted vehicle on an e-road and who uses that vehicle for purposes or in circumstances other than for which the exemption was granted, shall be liable to pay e-toll for the appropriate category of user as if the exemption had not been granted.

Information required and procedures applicable in respect of exempt NGO vehicles and exempt NPO vehicles

5. (1) A non-government organisation (NGO) or non-profit organisation (NPO) who registers a vehicle as an exempt NGO or exempt NPO vehicle, as the case may be, must provide the Agency with–

- (a) proof that the NGO or NPO has been approved by the South African Revenue Service as a public benefit organisation under section 30 of the Income Tax Act, 1962 (Act No 58 of 1962);
- (b) proof that the NGO or NPO was established for the purposes of health care, persons with disabilities, welfare or humanitarian purposes or education and development; and
- (c) a written undertaking that the vehicle will be used by the relevant NGO or NPO.

(2) A person who registers a vehicle as an exempt NGO vehicle or exempt NPO vehicle must also provide the Agency with–

- (a) the information contemplated in the attached Annexure A in respect of each vehicle, by completing such Annexure and submitting the completed Annexure to the Agency; and
- (b) an undertaking to comply with the conditions of registration, insofar as they apply to exempt NGO vehicles or exempt NPO vehicles, as the case may be, and the e-Road Regulations.

(3) A certified copy of the current motor vehicle licence certificate for each exempt NGO and NPO vehicle must be submitted with the application.

(4) The user of an exempt NGO vehicle or exempt NPO vehicle on an e-road and who uses that vehicle for purposes or in circumstances other than for which the exemption was granted, shall be liable to pay e-toll, for the appropriate category of user as if the exemption had not been granted.

Information required and procedures applicable in respect of rebate for persons conveying persons with disabilities

6. (1) The owner of a vehicle conveying persons with disabilities who qualifies for a rebate must submit a registration form for the rebate in the format shown in Annexure B, and if the rebate is approved that owner must submit a monthly claim form in the format shown in Annexure C and the rebate will appear as a discount on the user's next monthly statement.

(2) The form mentioned in sub-regulation (1) must include—

- (a) a statement confirming particulars of trips where the person or persons with disabilities were conveyed;
- (b) a statement that the vehicle was used to convey persons who qualify as persons with disabilities, being persons who have physical, mental, intellectual or sensory impairments which, in interaction with various barriers, may hinder their full and effective participation in society on an equal basis with others, or a medical condition such as autism, mental health, epilepsy loss of hearing, and which disability is permanent and impairs functional mobility; and
- (c) particulars of the the vehicle or vehicles as indicated on the form.

(3) The form mentioned in sub-regulation (1) must be accompanied by a certificate from a medical practitioner registered with the Health Professions Council of South Africa, including an impairment questionnaire, certifying that the person or persons qualify under sub-regulation (2)(b).

(4) The user of a vehicle subject to a rebate on an e-road and who uses that vehicle for purposes or in circumstances other than for which the rebate was granted, shall be liable to pay e-toll, for the appropriate category of user as if the rebate had not been granted.

Procedures applicable to all exemptions

7. (1) Where exemption has been granted by the Agency, as applicable, from the payment of toll on a particular e-road—

- (a) the person who registers a vehicle with the Agency will be issued with an e-tag by the Agency for each vehicle, which e-tag will constitute a means of identifying the vehicle in respect of which the exemption has been granted; and
- (b) a document identifying the person who registered with the Agency will be issued by the Agency, if so decided by the Agency, which document is not

transferable and which must be kept in the vehicle or on the person of the user when using an e-road for which exemption or rebate has been granted.

- (2) The e-tag issued by the Agency for each such vehicle–
 - (a) must, once issued, be affixed to each vehicle which has registered with the Agency in the manner specified in the Specification Regulations issued by the Minister in terms of section 58(1)(dB) of the Act; and
 - (b) must, in order for the vehicle to be exempt from the payment of toll, be affixed to the relevant vehicle or vehicles of the user, as applicable, when using an e-road: Provided that this requirement shall however not apply to exempt public transport vehicles, prior to expiry of the transition period mentioned in the relevant notice published in the Government Gazette to provide for the exemption.
- (3) The person who registers the vehicle with the Agency and for which exemption has been granted by the Agency must–
 - (a) within 14 days of changing his or her physical or postal address or any of the particulars supplied to the Agency at the time of registration, notify the Agency of his, her or its new address or such new particulars;
 - (b) notify the Agency within 24 hours after he, she or it becomes aware of the theft of the motor vehicle;
 - (c) furnish information regarding the motor vehicle which is or may have been at any time in his, her or its possession to any authorised officer as defined in the National Land Transport Act, if requested to do so;
 - (d) notify the Agency of any declaration that the motor vehicle has been declared unfit for use within 24 hours after the motor vehicle has so been declared unfit;
 - (e) notify the Agency within 24 hours of the e-tag becoming damaged or stolen or destroyed and re-apply for a new e-tag in terms of the e-Road Regulations; and
 - (f) ensure that the number plates of the motor vehicle that he, she or it is operating are affixed in the manner prescribed in regulation 35 of the National Road Traffic Regulations, 2000 made in terms of the National Road Traffic Act, and are clearly visible at all times.

(4) Registration will, subject to sub-regulation (9), be valid for three years from the date of registration of the vehicle and the person who registers the vehicle as an exempt vehicle, must apply to the Agency for renewal of the registration not less than 30 days prior to the registration having lapsed by completing the attached Annexure A and supplying the required particulars and documents to the Agency.

(5) If the vehicle that is exempt and is registered with the Agency, in terms hereof, is stolen, scrapped, sold or otherwise disposed of, or declared permanently unfit for use, the person who applied for registration of the vehicle must notify the Agency and supply the VLN or by telephoning an e-toll customer service centre, as contemplated in the e-Road Regulations, immediately on becoming aware that it was stolen, scrapped, sold or otherwise disposed of, or declared permanently unfit for use.

(6) The person who applied for registration of the vehicle in respect of which exemption was granted must notify the Agency within 24 hours if a vehicle registered with the Agency changes ownership or if an application is made to transfer the relevant operating licence or permit, or if the operating licence or permit lapses or is cancelled.

(7) If the person who applied for registration of the vehicle in respect of which exemption was granted elects to replace a vehicle with another vehicle and the new vehicle would still qualify for the exemption, then the person who applied for registration of the vehicle must apply for an e-tag for the new vehicle by completing the attached Annexure A and providing a certified copy of the motor vehicle licence certificate and other information required by the Agency, and the registration will not apply in respect of the new vehicle until the new e-tag issued by the Agency is affixed to the new vehicle in the manner prescribed in the Specification Regulations and, in the case of an exempt public transport vehicle, until the required operating licence for the new vehicle has been obtained.

(8) Exemption shall not apply where there has not been compliance with the requirements of sub-regulations (5), (6) and (7) and the user of the vehicle shall be liable to pay toll for the appropriate category of user as if the exemption had not been granted.

(9) Exemption from the payment of toll will lapse where—

- (a) the e-tag is used for any purpose other than in connection with the exemption granted to the vehicle;
- (b) the vehicle which is exempt from the payment of toll enters an e-road without the e-tag properly affixed to the vehicle: Provided that this requirement shall however not apply to exempt public transport vehicles, prior to expiry of the

transition period mentioned in the relevant notice published in the Government Gazette to provide for the exemption;

- (c) the person using or driving the vehicle fails to comply with these regulations or the e-Road Regulations;
- (d) the operating licence or permit, if applicable, on which exemption was granted lapses or is withdrawn or cancelled for any reason;
- (e) the vehicle for which the exemption is granted is at any time not properly licensed or a valid roadworthy certificate has not been acquired for the vehicle as required by the National Road Traffic Act; or
- (f) the person using or driving the vehicle tampers with or defaces a number plate on such vehicle in contravention of the National Road Traffic Act.

(10) Where a person is required by any provision contained in these regulations to give notice to the Agency of any occurrence or for purposes of complying with any provision of these regulations, then such notice must be given either by contacting the call centre or by visiting an e-toll customer service centre, or by any other means of notification that is given on the website as defined in the e-Road Regulations.

Requirements for owner of vehicle for which a rebate is claimed

8. In order to claim the rebate contemplated in regulation 6 for a vehicle the owner of the vehicle must—

- (a) be a registered user as defined in the e-Road Regulations;
- (b) have acquired an e-tag for and fitted it to the vehicle, and
- (c) have complied fully with the e-Road Regulations.

Repeal of regulations

9. The Regulations on Exemptions from the Payment of Tolls, 2013 published under notice R.741 of 9 October 2013 are hereby repealed.

Short title and commencement

10. These Regulations are called the Regulations on Exemptions from and Rebates on the Payment of Tolls, 2016 and shall come into operation on the date of publication in the *Government Gazette*.

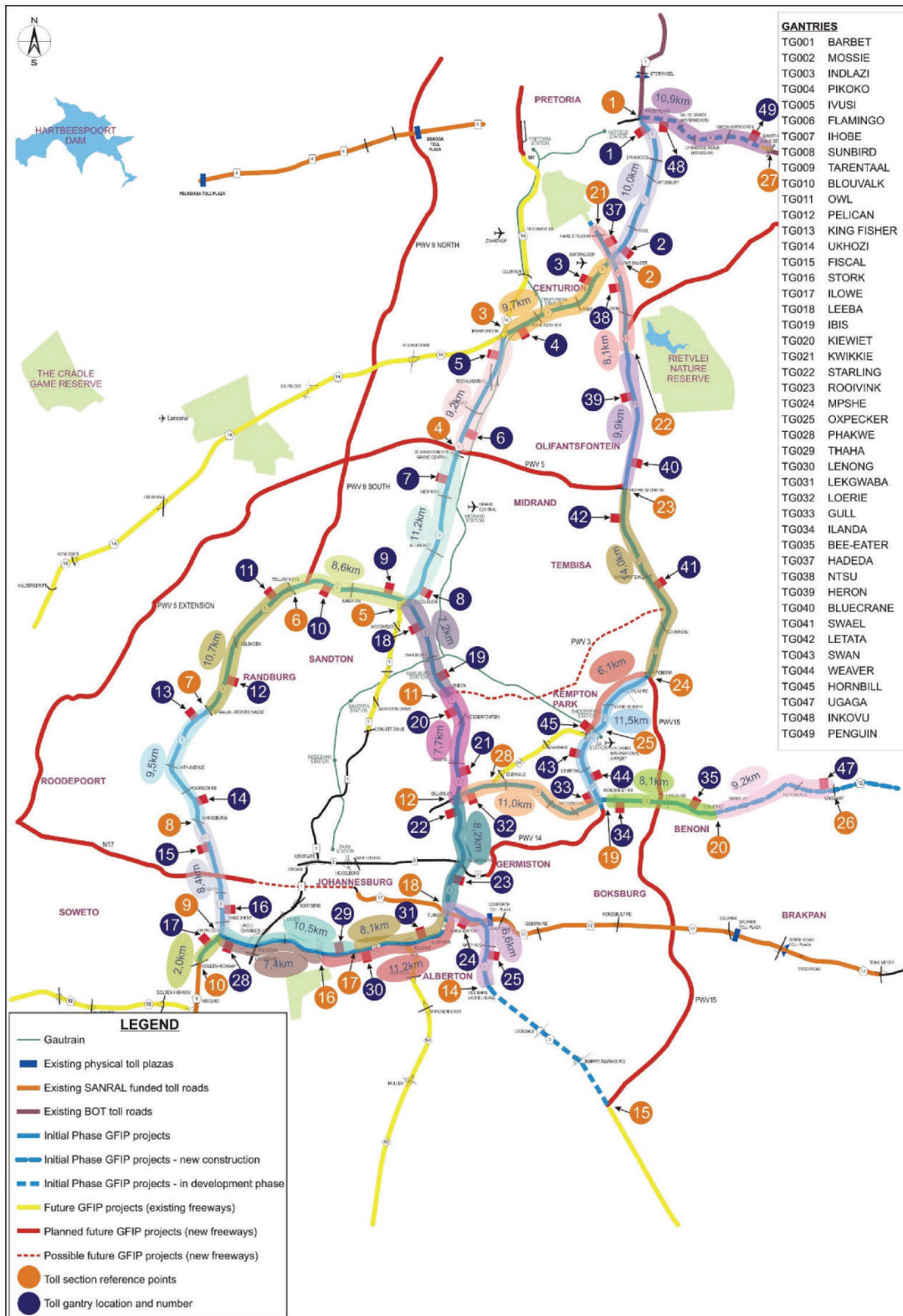

5. (1) 'n Nie-staats organisasie (NSO) of organisasie sonder winsoogmerk (OSW) wat 'n voertuig as 'n vrygestelde NSO-voertuig of OSW-voertuig, soos die geval mag wees, registreer, moet die Agentskap voorsien van—

- (a) bewys dat die NSO of OSW deur die Suid-Afrikaanse Inkomstediens as 'n openbare welsynsinstelling kragtens artikel 30 van die Wet op Inkomstebelasting, 1962 (Wet Nr. 58 van 1962) goeagekeur is;
 - (b) bewys dat die NSO of OSW vir doeleindes van gesondheidsorg, persone met ongeskikthede, welsyns- of medemenslikheidsdoeleindes gestig is, of onderwys en ontwikkeling; en
 - (c) 'n geskrewe onderneming dat die voertuig deur die betrokke NSO of OSW gebruik sal word.

6. (1) Die eienaar van 'n voertuig wat persone met ongeskikthede vervoer en wat vir 'n korting kwalifiseer moet 'n registrasievorm vir die korting indien in die formaat getoon in Aanhangel B, en as die korting goedgekeur word moet sodanige eienaar 'n maandelikse eisvorm indien in die format getoon in Aanhangel C, en sal die korting as 'n afslag op die gebruiker se volgende maandelikse staat verskyn.

(2) Die vorm gemeld in sub-regulasie (1) moet insluit-

(a) 'n verklaring wat besonderhede van die ritte waar die persoon of persone met ongeskikthede vervoer is, bevestig;

- (a) binne 14 dae nadat sy of haar fisiese- of posadres, of enige van die besonderhede wat tydens registrasie aan die Agentskap verskaf is, verander

is, die Agentskap van sy of haar nuwe adres of sodanige nuwe besonderhede in kennis stel;

- (b) die Agentskap binne 24 uur in kennis stel nadat dit tot sy of haar kennis gekom het dat die motorvoertuig gesteel is;
- (c) inligting aangaande die vrygestelde voertuig wat te enige tyd in sy of haar besit was, aan enige bevoegde beampte soos in the Nasionale Landvervoerwet omskryf, verskaf, indien aldus versoek;
- (d) die Agentskap in kennis stel van enige verklaring dat die motorvoertuig ongeskik is vir diens binne 24 uur nadat die motorvoertuig aldus ongeskik verklaar is;
- (e) die Agentskap binne 24 uur in kennis stel indien die e-tag beskadig of gesteel is en weer vir 'n nuwe e-tag ingevolge die e-Pad Regulasies aansoek doen; en
- (f) verseker dat die nommerplate van die motorvoertuig wat hy of sy bedryf op die wyse voorgeskryf in regulasie 35 van die Nasionale Padverkeerregulasies, 2000, welke regulasies kragtens die Nasionale Padverkeerwet gemaak is, aangebring is, en dat dit te alle tye duidelik sigbaar is.

(4) Registrasie sal, behoudens sub-regulasie (9), vir drie jaar vanaf die datum van registrasie van die vrygestelde voertuig, geldig wees, waarna die registrasie verval en die persoon wat kies om die voertuig as 'n vrygestelde voertuig te registreer, by die Agentskap aansoek moet doen om hernuwing van die registrasie nie minder as 30 dae voor die registrasie sal verval, deur die aangehegte Aanhangsel A te voltooi en die benodigde besonderhede en dokumente aan die Agentskap te verskaf.

(5) Indien die voertuig wat vrygestel is en by die Agentskap in terme hiervan geregistreer is, gesteel, gesloop, verkoop of andersins vervreem word, of permanent vir diens ongeskik verklaar is, moet die persoon wat om registrasie aansoek gedoen het die Agentskap in kennis stel en die VLN verskaf of 'n e-tol kliëntedienssentrum telefoneer, soos beoog in die e-Pad Regulasies, onmiddellik nadat dit tot sy of haar kennis gekom het dat dit gesteel, gesloop, verkoop of andersins vervreem is, of permanent vir diens ongeskik verklaar is.

(6) Die persoon wat aansoek gedoen het om registrasie van die voertuig met betrekking waartoe vrystelling verleen is, moet die Agentskap binne 24 uur in kennis stel indien 'n voertuig wat by die Agentskap geregistreer is van eienaarskap verander of indien

aansoek gedoen word om die betrokke bydryfslisensie of permit oor te dra, of indien die bedryfslisensie of permit verval of gekanselleer word.

(7) Indien die persoon wat aansoek gedoen het om registrasie van die voertuig waarvoor vrystelling verleen is, kies om die voertuig met 'n ander voertuig te vervang en die nuwe voertuig ook nog kwalifiseer vir die vrystelling wat deur die Agentskap verleen is, moet die persoon wat aansoek gedoen het om registrasie van die voertuig aansoek doen om 'n e-tag vir die nuwe voertuig deur die aangehegde Aanhangel A te voltooi en 'n gesertifiseerde afskrif van die voertuiglisensiesertifikaat te verskaf, asook ander inligting wat die Agentskap benodig, en die registrasie sal nie op die nuwe voertuig van toepassing wees nie totdat die nuwe e-tag wat die Agentskap verskaf by die nuwe voertuig aangebring is op die wyse voorgeskryf in die Spesifikasie Regulasies en, in die geval van 'n vrygestelde openbare vervoervoertuig, totdat die nodige bedryfslisensie vir die nuwe voertuig verkry is.

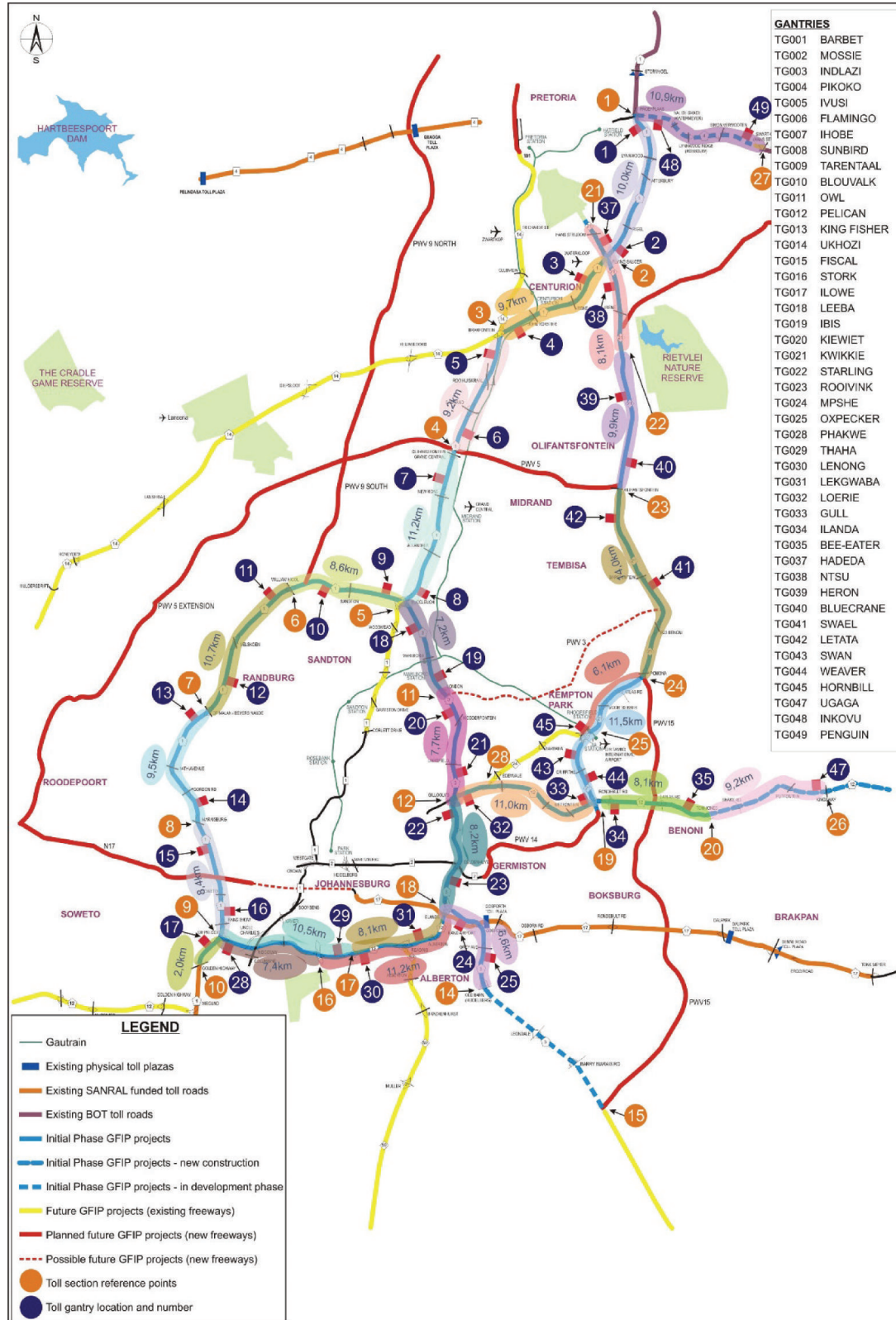
