**MAGISTRATES' COURTS ACT 1944 (ACT NO. 32 OF 1944): WITHDRAWAL OF A NOTICE ANNEXING THE SUB-DISTRICT OF VUWANI TO THE MAGISTERIAL DISTRICT OF THULAMELA (THOHOYANDOU)**

I, Tshililo Michael Masutha, Minister of Justice and Correctional Services, under section 2(1)(l), of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944), as amended hereby -

withdraw Notice No. 677 published in the *Government Gazette* No. 40044 of 2 June 2016 which annexed the sub-district of Vuwani to the magisterial district of Thulamela with the seat of the magistracy in Thohoyandou,

thus restoring the legal position in terms of which Vuwani is a sub-district of the Malamulela Magisterial District.
