By virtue of the powers vested in me in terms of section 9(1) of the Broad-Based Black Economic Empowerment amendment Act 46 of 2013 and in accordance with the provisions of paragraphs 3.6 of Statement 100 as per amended B-BBEE Code Series 100, I Dr. Rob Davies, Minister of Trade and Industry hereby designates and grants a B-BBEE Facilitator Status extension to Denel for a period of seven (7) years effective from the date of my signature.

The B-BBEE Facilitator Status granted to Denel (Pty) Ltd is designated and confined exclusively for dealings with its associate companies namely Turbomeca Africa (Pty) Ltd, Rheinmetal Denel Munition (Pty) Ltd and Airbus DS Optronics (Pty) Ltd. All business dealings within the Denel Group including any other subsidiary, joint venture and associate company will fall outside the scope of this exemption.
