**NOMINATION OF CANDIDATES FOR APPOINTMENT TO THE AGRICULTURAL PRODUCE AGENTS COUNCIL (APAC): AGRICULTURAL PRODUCE AGENTS ACT 1992, (ACT No. 12 OF 1992)**

The Minister of Agriculture, Forestry and Fisheries hereby invites nominations of suitable persons to be considered for appointment as members of the Agricultural Produce Agents Council (APAC).

The objective of the APAC is to regulate the occupations of fresh produce, export and livestock agents and to maintain and enhance the status and dignity of those occupations as well as the integrity of persons practicing those occupations.

Nominations are hereby called for persons that represent the following:

- Fresh Produce Producer (1)
- Fresh Produce Agent (1)
- Livestock Producer (1)
- Livestock Agent (2)
- Export Agents (1)

Nominees should indicate the category under which they wish to be considered and supply a written acceptance of the nomination, submit copy of ID document, comprehensive curriculum vitae, **documentary proof of all qualifications** and a declaration that proves that he or she is not disqualified to serve on the Council in terms of section 3(7) of the above-mentioned Act.

The nomination of candidates that are characteristically representative of race and gender-equity is encouraged.

Members of the Council shall be paid remuneration or allowances from the funds of the Council, as the Council may determine.

Members are appointed for a maximum of three years in terms of section 3(1) of the Act.

Successful candidates would be subjected to a personnel suitability check regarding citizenship, criminal record and qualification verification.
