KTH MEDIA FM (PTY) LTD (EAST COAST RADIO)**

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received an application from KTH Media Investment (PTY) Ltd, for an amendment of its Radio Frequency Spectrum (RFS) Licence lodged in terms of the provision of section 31(4) of the Electronic Communications Act, No. 36 of 2005 (ECA) read with procedures set out in Regulation 9 of the Radio Spectrum Frequency Regulations, Notice 279 of 2015 as published on Government Gazette No. 38641. The KTH Media Investment (PTY) Ltd propose to relocate frequency licensed in Nongoma to Ulundi and increase ERP from 10 kW to 30 kW. The details and specifications of the application are contained in the table below.
2. Interested persons are invited to submit written representation in relation to the application within twenty one (21) working days from the date of the publication of this notice in the government gazette.
