INCREASE IN RESPECT OF SOCIAL GRANTS

The Minister of Social Development has, in terms of the Social Assistance Act, 2004 (Act No. 13 of 2004) as amended, with the concurrence of the Minister of Finance, announced the increase in social grants.

The new maximum monthly amounts are as follows:

Type of Grant	Current Amount	New Amount 1 October 2016
Older Persons (60 – 74 yrs)	R 1 500	R 1 510
Older Persons (75+ yrs)	R1 500 + R20	R1 510 + R20
War Veterans'	R1 500 + R20	R1 510 + R20
Disability	R 1 500	R 1 510
Care Dependency	R 1 500	R 1 510
Child Support	R350	R360
Grant-in-Aid	R350	R360

The increases will be effected on 1 October 2016.
