INSURANCE ACT, 1998 (ACT NO. 53 OF 1998)****PROPOSED REPLACEMENT OF THE POLICYHOLDER PROTECTION RULES**

I, Jonathan Ian Dixon, Deputy Registrar of Long-term Insurance and Deputy Registrar of Short-term Insurance, hereby, under the Long-term Insurance Act, 1998 (Act No. 52 of 1998) and Short-term Insurance Act, 1998 (Act No. 53 of 1998) ("the Acts"), publish for public comment the proposed replacement of the Policyholder Protection Rules ("PPRs") made under section 62 of the Long-term Insurance Act, 1998 and section 55 of the Short-term Insurance Act, 1998.

The proposed replacement of the PPRs is necessary to give effect to a number of important conduct of business reforms.
