

NATIONAL ROAD TRAFFIC ACT, 1996 (ACT NO. 93 OF 1996)

**DETERMINATION AND IMPLEMENTATION OF THE CURRICULA FOR
TRAFFIC OFFICERS**

The Minister of Transport, acting in terms of section 75 of the National Road Traffic Act, 1996, read with regulation 2B of the National Road Traffic Regulations, 2000 hereby intends to determine and implement the curricula for traffic officers registered by South African Qualifications Authority under registration South African Qualification Identity number: 97639 with effect from 1 March 2017: Provided that any traffic officer's qualification obtained or is in a process of being obtained from a training centre referred to in section 3D (1)(a) of the National Road Traffic Act, 1996 (Act No. 93 of 1996) prior to 1 March 2017 shall be recognised.

All interested parties who have any objections, inputs or comments to the proposed amendments are called upon to lodge their objections, inputs or comments, within four weeks from the date of publication of this Notice to:
