## PETROLEUM PRODUCTS ACT, 1977 (ACT No. 120 OF 1977)

REGULATIONS IN RESPECT OF THE SINGLE MAXIMUM NATIONAL  
RETAIL PRICE FOR ILLUMINATING PARAFFIN

1. I, Ms. Tina Joemat-Pettersson, Minister of Energy, under section 2(1)(c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), determine that a maximum retail price for Illuminating Paraffin (excluding the price of any form of packaging) will become effective on the first Wednesday of every month.
2. The single maximum retail price for illuminating paraffin, excluding the price of any form of packaging for the period 04 January 2017 to 31 January 2017 will be 954.0 c/l.
3. **Commencement**  
These regulations shall come into operation at **00:01 on 04 January 2017**.
