Schedule 2:	Part 61 (Pilot Licensing)
Schedule 3:	Part 91 (General Aviation and Operating Flight Rules)
Schedule 4:	Part 93 (Corporate Operations)
Schedule 5:	Part 121 (Air Transport Operations – Carriage on Aeroplanes of more than 19 Passengers or Cargo)
Schedule 6:	Part 127 (Commercial Helicopter Operations: passengers, cargo and mail)
Schedule 7:	Part 128 (Helicopter Aerial Work and Certain other Air Service Operations)
Schedule 8:	Part 135 (Air Transport Operations – Carriage of less than 20 Passengers or Cargo)

The Director of Civil Aviation intends, in terms of section 163 of the Civil Aviation Act and on the recommendation of CARCom, to amend the Technical Standards by the amendment of the following parts set out in the Schedules below:
