1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received applications from China Times cc for transfer of its Individual Electronic Communications Service ("I-ECS") and Individual Electronic Communications Network Service ("I-ECNS") licences. The applications were lodged in terms of regulation 11 of the Processes and Procedures Regulations for Individual Licences and Special Temporary Authorisations of 2016, read with sections 13(1), (2) and (6) of the Electronic Communications Act 2005, as amended.
2. The transfer applications seek the approval from the Authority to transfer the I-ECNS and I-ECS licences from China Times cc (Pty) Ltd ("applicant") to K2015351513 South Africa (Pty) Ltd ("transferee") and will be evaluated on the basis of the following criteria:
 - a. promotion of competition in the ICT sector;
 - b. interests of consumers; and
 - c. equity ownership by HDP'S.
3. The transferee submitted that it is 100% owned by historically disadvantaged persons.
4. The applications, relevant schedule and any representations received pursuant thereto will be made available and open for inspection by any interested party in the Authority's library, during the Authority's office hours.

5. Any interested party is invited to lodge written representations to the applications within fourteen (14) working days from the date of publication of this notice in the Government Gazette.
6. Any person who would like to make representations must indicate whether they require an opportunity to make oral representations in the event the Authority decides to hold public hearings.

9. China Times cc has the right to respond in writing to written representations made by any interested person on the transfer applications. The written responses must be lodged with the Authority within twenty-one (14) working days from the date of publication of this notice in the Government Gazette.

China Times cc must, at the time of lodging the written response, furnish proof to the Authority's satisfaction that it has delivered a copy of the response by hand, **OR** has sent a copy thereof by registered mail **OR** by facsimile **OR** by e-mail to the relevant person having made the written representations.
