

I, Gugile Ernest Nkwintl, Minister of Rural Development and Land Reform, under section 1(1)(a)(iii) of the Deeds Registries Act, 1937 (Act No. 47 of 1937), hereby amend, with effect from the date of publication of this Notice in the *Government Gazette*, the definition of the area of the deeds registry at Pretoria, as set out in the Schedule to Government Notice No. R. 861, published in *Government Gazette* No. 30288 of 25 September 2007, by excluding the Province of Limpopo as defined in Schedule 1A to the Constitution of the Republic of South Africa, 1996 (Act No. 108 of 1996), from the area defined in the said Schedule to Government Gazette Notice No. R861.


