BILL, 2017**

1. Notice is hereby given in terms of Rule 276(1)(b) of the Rules of the National Assembly that the Minister of Justice and Correctional Services intends introducing the Legal Practice Amendment Bill, 2017, in the National Assembly shortly.

2. The explanatory summary of the Bill is hereby published in accordance with Rule 276(1)(c) of the Rules of the National Assembly.

The purpose of the Bill is to amend the Legal Practice Act, 2014, so as to further regulate the prescription of the areas of jurisdiction of the Provincial Councils; to provide that only practising legal practitioners may perform certain acts or render certain services; to further regulate the duties of banks in respect of trust accounts; to further regulate the duration of the National Forum on the Legal Profession; to further provide for the functions of the National Forum on the Legal Profession; to further provide for the dissolution date of the law societies; and to provide for matters connected therewith.

1. Kennis word hiermee ooreenkomstig Reël 276(1)(b) van die Reëls van die Nasionale Vergadering gegee dat die Minister van Justisie en Korrektiewe Dienste beoog om die Wysigingswetsontwerp Op Regspraktyk, 2017, eersdaags in die Nasionale Vergadering in te dien.
2. Die verduidelikende opsomming van die Wetsontwerp word hierby ooreenkomstig Reël 276(1)(c) van die Reëls van die Nasionale Vergadering gepubliseer.

Die Wetsontwerp het ten doel om die Wet op Regspraktyk, 2014, te wysig, ten einde voorsiening te maak vir die voorskrif van die areas van jurisdiksie van die Provinsiale Rade; om voorsiening te maak dat slegs praktiserende regspraktisyns sekere werk mag verrig of sekere dienste mag lewer; om verder voorsiening te maak vir die pligte van banke ten opsigte van trustrekeninge; om verder voorsiening te maak vir die duur van die Nasionale Forum oor die Regsprofessie; om verder voorsiening te maak vir die funksies van die Nasionale Forum oor die Regsprofessie; om verder voorsiening te maak vir die ontbindingsdatum van die prokureursordes; en om voorsiening te maak vir verbandhoudende aangeleenthede.
