Amendment of regulation 187.02.1 of the Regulations

3. Regulation 187.02.1 is hereby amended by the substitution for sub-regulation (1) of the following sub-regulation:

“(1) A civil aviation authority passenger safety charge amounting to **[R20.23]** R22.29 shall be payable by aircraft passengers departing on an aircraft from an aerodrome within the Republic of South Africa on a scheduled public air transport flight or part of a flight to a destination within or outside the territory of the Republic of South Africa.”.

Short title and commencement

4. This Amendment is called the Seventeenth Amendment of the Civil Aviation Regulations, 2017 and shall come into operation on 1 July 2017.
