AMENDMENT OF GOVERNMENT NOTICE NO. 563 OF 13 JUNE 2017: COMMENCEMENT OF FINANCIAL INTELLIGENCE CENTRE AMENDMENT ACT, 2017

I, Malusi KN Gigaba, the Minister of Finance, hereby amend Government Notice No. 563 of 13 June 2017 in—

- (a) paragraph (a), in respect of the commencement of section 1(k) of the Financial Intelligence Centre Amendment Act, 2017 (Act No. 1 of 2017 – herein called “the Act”), by the substitution for the word “investigate” of the word “investigative”;
- (b) paragraph (a), in respect of the commencement of section 28 of the Act, by the substitution for the words “substitutes section 42B of” of the words “inserts section 42B in”;
- (c) paragraph (a), in respect of the commencement of section 50 of the Act, by the substitution for the term “section 68(1)” of the term “section 68(2)”;
- (d) paragraph (b), in respect of the commencement of section 28 of the Act, by the substitution for the words “substitutes 42A of” of the words “inserts section 42A in”; and
- (e) paragraph (b), in respect of the commencement of section 50 of the Act, by the substitution for the term “section 68(1)” of the term “section 68(2)”.
