Notice is hereby given in terms of Section 49(1)(a)(i) read together with Section 78(1) of the Local Government: Municipal Property Rates Act, 2004, (Act No.6 of 2004), hereinafter referred to as the "Act", that the Third Supplementary Valuation Roll of the period 1 July 2013 to 30 June 2018, is open for public inspection and lodging of objections at the Municipality offices from **14 August 2017 to 25 September 2017**.

An invitation is hereby made in terms of Section 49(1)(ii), read together with Section 78(1) of the Act, that any owner of property or other person who so desires should lodge an objection with the Municipal Manager in respect of any matter reflected in, or omitted from, the Third Supplementary Valuation Roll within the above-mentioned period.


Attention is specifically drawn to the fact that in terms of Section 50(2) of the Act, an objection must be in relation to a specific individual property and not against the Third Supplementary Valuation Roll as such. The prescribed form for the lodging of an objection is obtainable at the Municipal offices.

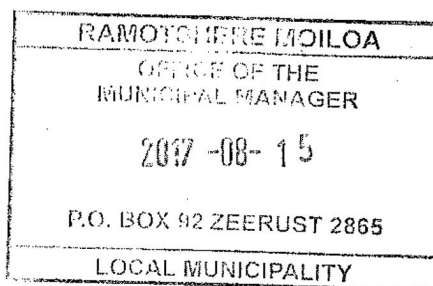
Closing date for objections is 16:00 on 4th September 2017. No late objections will be considered by the Municipal Valuer or the Valuation Appeal Board.

In terms of Section 50(6) of the Act, the lodging of an objection **does not defer** liability for payment of rates beyond the date determined for payment.
