NOTICE OF NOMINATIONS TO FILL VACANCIES ON THE SOUTH AFRICAN DENTAL TECHNICIANS COUNCIL IN TERMS OF THE DENTAL TECHNICIANS ACT, 1979 (ACT 19 OF 1979)

Institutions and/or individuals are hereby invited to nominate persons to fill vacancies of non-executive members to the South African Dental Technicians Council of South Africa (SADTC), appointed by the Minister of Health, Dr Aaron Motsoaledi in terms of Section 5(1) (b) of the Dental Technicians Act, 1979 (Act 19 of 1979), as amended (hereinafter referred to as "the Act"), for the current term of office expiring on 31 August 2017 as follows: (i) a Dentist attached to university having a dental faculty; and (ii) a Dental Technician or Dental Technologist attached to an institution at which dental technician or dental technologists are educational and trained.

Kindly refer to section 6 of the Act for conditions under which a person may be disqualified from membership of the SADTC.
