**DETERMINATION OF PERSONS OR CATEGORY OR CLASS OF PERSONS WHO ARE COMPETENT TO BE APPOINTED AS INTERMEDIARIES: AMENDMENT OF GOVERNMENT NOTICE NO. R. 663 OF 14 JULY 2017**

I, Tshililo Michael Masutha, Minister of Justice and Correctional Services, hereby, amend Government Notice No. R. 663 published in Government *Gazette* No. 40976 of 14 July 2017, by the substitution for item (vi) of paragraph (a) of the said Government Notice of the following item:

- “(vi) Child and youth care workers who have—
- (aa) obtained a minimum post-matriculation education qualification of three years at a recognised tertiary educational institution in child and youth care;
  - (bb) at least three years' experience in child or youth care; and
  - (cc) are registered in terms of section 18A of the Social Service Professions Act, 1978 (Act No. 110 of 1978).”.
