BOARD NOTICE 190 OF 2017**THE SOUTH AFRICAN COUNCIL FOR THE ARCHITECTURAL PROFESSION**

Notice is hereby given that the South African Council for the Architectural Profession has in terms of section 36 (3) of the Architectural Profession Act 44 of 2000 published the amended Rule 8 (2) for the Procedure of Nomination of SACAP Council Members.

It is hereby made known that Rule 8 (2) of the Procedure of Nomination of SACAP Council Members, Board Notice 223 of 2013 dated 1 November 2013 is hereby amended as follows:

Rule 8 (2)

The Recommendation Panel shall be appointed by the Council and shall be constituted as follows by people who are not members of the outgoing Council:

- a) One registered person from each category of registration;
- b) One registered person with specialised knowledge of the Architectural Profession;
- c) One person nominated by the Director General of the Department of Public Works. In the event that the Director General of the Department of Public Works does not furnish Council with its nominee after being notified, the Recommendation Panel shall proceed with its work without such a nominee.
- d) Two persons from the Public;
- e) Any other two persons nominated by the Council to ensure transformational representivity;
- f) One person who has legal knowledge of both the Act and the SA Constitution.
