CALL REQUESTING NOMINATIONS OF SUITABLE PERSONS TO BE APPOINTED BOARD MEMBERS OF THE SOUTH AFRICAN WEATHER SERVICE

I, Bomo Edith Edna Molewa, Minister of Environmental Affairs, hereby call on all South Africans, in terms of section 5(3) read with section 5(2)(b) of the South African Weather Service Act, 2001 (Act No. 8 of 2001), to nominate suitable persons to be appointed board members of the South African Weather Service. In accordance with the South African Weather Service Act, 2001, I am specifically seeking nominations with relevant expertise in: subsistence farmers and disadvantaged communities, media, disaster management, aviation industry, maritime industry, other weather sensitive industry or occupation, and atmospheric science education and research community.

Members of the public are invited to submit to the Minister, within 30 days after the publication of this government notice in the *Gazette*, written nominations of suitable persons to be appointed as board members of the South African Weather Service. A nomination of a suitable person must include the following:

- curriculum Vitae of the nominee with Personal details, including postal and residential address and contact number of the nominee;
- certified copies of both academic qualifications and identity document;
- experience of the nominee with reference to the criteria contained in section 5(2) of the South African Weather Service Act, 2001 (Act No. 8 of 2001); and
- acceptance letter from the nominee.
