## BOARD NOTICE 196 OF 2017



**Rules relating to the payment of fees for registered persons with the Council for the Project and Construction Management Professions (Act 48 of 2000)**

Amendments to Board Notice published in the Government Gazette Board Notice No 41295 of 01 December 2017 with regard to Schedule of Fees for 2018 in terms of Section 12 of the Projects and Construction Management (Act 48 of 2000)

1. The notice is effective from 01 January 2018
2. Renewal fees in Section 22 of the Project and Construction Management (Act 48 of 2000) – persons registered with the Council in terms of the Act are required to pay the applicable fee in January of each year.
3. An Administrative fee will be charged should the applicable annual fee not be paid within the prescribed period.
4. The annual fee for initial registration is calculated on a pro-rata dependent on which month of the year registration takes place.

The fees prescribed herein include Value Added Tax (VAT)
