

Allied Health Professions Act (Act No. 63 of 1982)**INCLUSION OF THE PROFESSION OF AROMATHERAPY AND REFLEXOLOGY UNDER THE PROVISIONS OF THE ALLIED HEALTH PROFESSIONS ACT, 1982**

I, Aaron Motsoaledi, Minister of Health, hereby in terms of section 16 of the Allied Health Professions Act (Act No. 63 of 1982) and in consultation with the Allied Health Professions Council of South Africa, declare the provisions of the Act to be applicable to the following professions, which has as its object the promotion of health, or the treatment, prevention or relief of physical or mental defects, illnesses or deficiencies in humans:

- (a) Aromatherapy; and
- (b) Reflexology.

Interested persons are invited to submit any substantiated comments or representations in writing on the proposed Notice to the Director-General of Health, Private Bag 828, Pretoria, 0001 (for the attention of the Director: Public Entities Governance: Ms M Mushwana, MushwM@health.gov.za), within three (3) months of the date of publication of this notice
