

NOTICE ON THE APPOINTMENT OF MEMBERS OF THE ADVISORY BODY TO THE GOVERNMENT EMPLOYEES HOUSING SCHEME (GEHS)

9 February 2018

The Public Service Co-ordinating Bargaining Council (PSCBC), in terms of Resolution 7 of 2015, established the Government Employees Housing Scheme (GEHS), which started operating on 1 July 2015. The purpose of the Scheme is to assist government employees to access affordable housing through the management of the housing allowance and other support interventions. PSCBC Resolution 5 of 2017 establishes an Advisory Body for the GEHS, which advises the Minister for Public Service and Administration on the following matters:

- (i) Strategic direction of the scheme;
- (ii) The efficiency of the administration of the scheme;
- (iii) Consider and receive reports on the financial sustainability of the structure;
- (iv) Consider the scheme benefit offering;
- (v) Consider the bettering of the member benefit structure;
- (vi) Receive and consider reports on membership satisfaction; and
- (vii) To consider and assist with ongoing membership education.

In terms of PSCBC Resolution 5 of 2017, the Advisory Body comprises 6 members nominated by the employer and 6 members nominated by the admitted trade unions in Council.
